Situated in the State of Ohio, County of Muskingum, Township of Wayne and being part of the Northeast Quarter of Section 13, Township 12, Range 13, also being all of the lands now owned by Herschel G. Stall & Marvel F. Stall (DR 513-235) of the Muskingum County Recorder more fully described as follows.

Beginning for reference at a stone called for and calculated in by previous deed record at the southeast corner of the northeast quarter of said Section 13;
thence N 12°39'12" W, 962.96 feet to a point in the center of Wayne Ridge Road (CR-73), and the principal place of beginning;

thence with the north line of Lot 1 of Country Side Acres (PB 13, Pg. 92), S 85°05'43" W, 126.52 feet to an iron pin set at the common corner of said Herschel G. Stall & Marvel F. Stall's lands (DR 554-105 & DR 513-235), passing a pipe found at 20.93 feet, said iron pin set is referenced by a pipe found which bears, S 85°05'43" W, 349.24 feet;

thence leaving said north line and going with the common line of said Stall's lands the following two (2) courses:

1. N 07°27'34" E, 196.16 feet to an iron pin set;
2. S 74°30'26" E, 126.50 feet to a point in the center of said Wayne Ridge Road, passing an iron pin set at 105.46 feet;

thence with the center of said Wayne Ridge Road, S 08°05'34" W, 151.40 feet to the place of beginning, containing a total of 0.496 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 0.496 acre parcel is based on a field survey made by McPeek Land Surveying on April 17th, 2017
