SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE AND BEING A PART OF THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 12, RANGE 13 OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER AND BEING A PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 571, PAGE 319 OF THE MUSKINGUM COUNTY DEED RECORDS; AND BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:
