

**New Property Description**

**3.592 Acres on Frick Road**

Situated in the County of Muskingum, in the State of Ohio, and in the Township of Wayne, Township 11, Range 13, Section 4, and bounded and described as follows:

Commencing for reference at the Northwest corner of the Northeast Quarter of said Section 4; thence run South 05 degrees 05 minutes 09 seconds West a distance of 650.76 feet (by deed) along the West line of the Northeast Quarter of said Section 4 to the Southeast corner of the property owned by Joseph Gorshe et al (Deed Book 1093, Page 479); thence run North 85 degrees 40 minutes 42 seconds West along the Southerly line of said Joseph Gorshe et al property a distance of 18.0 feet to the Northeast corner of the property owned by Larry Paul and Carolyn Paul (Deed Book 1569, Page 32); thence run South 03 degrees 56 minutes 40 seconds West along the Easterly line of said Paul property a distance of 28.0 feet to the Place of Beginning of the premises herein intended to be described, said point being the Northwest corner of the 26.81 acre tract recorded in Deed Book 272, Pages 18 & 19, and being the Northwest corner of the 3.592 acre tract herein described; thence run South 86 degrees 00 minutes 00 seconds East along the Northerly line of said 26.81 acre tract a distance of 556.00 feet to an iron pin found; thence run South 37 degrees 02 minutes 00 seconds West a distance of 94.00 feet to a railroad spike found in the pavement of Frick Road; thence run South 39 degrees 04 minutes 01 second West a distance of 110.30 feet to a railroad spike found in the pavement of Frick Road; thence run South 47 degrees 50 minutes 01 second West a distance of 80.90 feet to a railroad spike found in the pavement of Frick Road; thence run South 23 degrees 56 minutes 00 seconds West a distance of 126.16 feet to a railroad spike found in the pavement of Frick Road, and being the Southeast corner of the 3.592 acre tract herein described; thence run South 89 degrees 21 minutes 25 seconds West, passing through an iron pin found at 15.00 feet, a total distance of 343.11 feet to an iron pin found on the Westerly line of the aforementioned 26.81 acre tract, and being the Southwest corner of the 3.592 acre tract herein described; thence run North 03 degrees 56


minutes 40 seconds East, passing through an iron pin (rebar) set at 106.79 feet, a total distance of 373.82 feet to the Place of Beginning, containing 3.592 acres, more or less.
