Situated in the State of Ohio, County of Muskingum, Township of Wayne.

Being a part of the Southeast Quarter of Section 4, Township 11, Range 13 bounded and described as follows:

Beginning at a stone found at the southeast corner of said Section 4; thence along the south line of said Section 4 north 84 degrees 28 minutes 34 seconds west 1055.58 feet to an iron pin found at the southeast corner of a 9.99 acre parcel conveyed to Marvin D. Stoneburner by deed recorded in Deed Book 675, Page 34; thence along the easterly line of said Marvin D. Stoneburner north 34 degrees 13 minutes west 1332.28 feet to a point in the center of Lawhead Lane; thence along the center of said Lawhead Lane the following twelve (12) courses and distances south 84 degrees 29 minutes 51 seconds east 606.92 feet to a point; thence south 76 degrees 28 minutes 20 seconds east 108.67 feet to a point; thence south 48 degrees 25 minutes 30 seconds east 62.93 feet to a point; thence south 35 degrees 45 minutes 50 seconds east 82.73 feet to a point; thence south 43 degrees 38 minutes east 84.21 feet to a point; thence south 55 degrees 09 minutes 30 seconds east 125.45 feet to a point; thence south 64 degrees 06 minutes 20 seconds east 124.51 feet to a point; thence south 73 degrees 48 minutes 29 seconds east 111.30 feet to a point; thence south 86 degrees 41 minutes 54 seconds east 175.19 feet to a point; thence south 85 degrees 28 minutes 20 seconds east 242.93 feet to a point; thence north 89 degrees 08 minutes 50 seconds east 107.48 feet to a point; thence north 82 degrees 28 minutes 15 seconds east 169.78 feet to an iron pin found in the center of Lawhead Lane; thence leaving said Lane and along the east line of Section 4 south 5 degrees 40 minutes 12 seconds west 791.21 feet to the place of beginning, containing twenty-eight and twenty-one hundredths (28.21) acres more or less.

Reserving a right of way to a 50 acre parcel to the east of the above described 28.21 acres as described in Deed Book 601, Page 185.
