BEING ALL OF A TRACT CONVEYED TO L. AND C. SOLLER IN DEED VOLUME 891 PAGE 317 AS RECORDED IN THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN THE NORTHEAST QUARTER OF SECTION 3, TOWNSHIP 11, RANGE 13, CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING 5/8 INCH REBAR AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 3; THENCE ALONG THE SOUTH LINE OF THE NORTHEAST QUARTER SOUTH 89 DEGREES 47 MINUTES 45 SECONDS EAST 133.41 FEET TO AN EXISTING 3/4 INCH PIPE, SAID POINT BEING THE PLACE OF BEGINNING OF THIS TRACT; THENCE NORTH 04 DEGREES 25 MINUTES 04 SECONDS WEST 102.43 FEET (110 FEET DEED) TO AN EXISTING AXLE; THENCE NORTH 89 DEGREES 50 MINUTES 56 SECONDS EAST 402.66 FEET TO THE CENTERLINE OF LAWHEAD LANE, PASSING AN EXISTING 3/4 INCH PIPE AT 274.39 FEET AND PASSING AN EXISTING AXLE AT 377.66 FEET; THENCE ALONG SAID CENTERLINE OF LAWHEAD LANE SOUTH 05 DEGREES 10 MINUTES 56 SECONDS WEST 105.00 FEET TO THE INTERSECTION OF THE CENTERLINE OF LAWHEAD LANE AND THE SOUTH LINE OF THE NORTHEAST QUARTER; THENCE ALONG SAID SOUTH LINE NORTH 89 DEGREES 47 MINUTES 45 SECONDS WEST 385.29 FEET TO THE PLACE OF BEGINNING, PASSING AN EXISTING 5/8 INCH REBAR AT 21.75 FEET.




