Commencing at an axle found at the Southwest Corner of Lot 1 of Saunders's Addition recorded in Plat Book II, Page 38; Thence South 85°05'00" East 100.00 feet to an iron pin set at the Southeast Corner of Lot 1 the place of beginning; Thence North 4°55'00" East along Lot 1, 150.00 feet to a 2" pipe found; Thence South 85°05'00" East along Karl Drive 120.00 feet to an iron pin set; Thence along the split line of Vol. 399, Page 463, South 4°55'00" West 150.00 feet to an iron pin set; Thence North 85°05'00" West 120.00 feet along A.& V. Kennedy Vol. 1132, Page 122 to the place of beginning containing 0.413 Acres more or less.

Commencing at an axle found at the Southwest Corner of Lot 1 of Saunders's Addition; Thence South 85°05'00" East 220.00 feet to an iron pin set the place of beginning; Thence along the split line of this property North 4°55'00" East 150.00 feet to an iron pin set; Thence South 85°05'00" East along Karl Drive 246.37 feet to a 2" pipe found; Thence South 28°47'00" West along Mound Road 164.03 feet to a 2" pipe found; Thence North 85°05'00" West along A&V Kennedy Vol. 1132, Page 122, 180.00 feet to the place of beginning containing 0.734 Acres more or less;
