THENCE WITH THE WEST LINE OF A TRACT CONVEYED TO ROBERT D. AND REGINA F. CROSS IN O.R. VOLUME 1580, PAGE 53, ALSO BEING THE EAST LINE OF A TRACT CONVEYED TO TIMOTHY E. CROSS IN O.R. VOLUME 2125, PAGE 440, NORTH 07 DEGREES 06 MINUTES 08 SECONDS EAST 452.85 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH CAP-BENT), SAID IRON PIN BEING THE **PLACE OF BEGINNING** OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE LEAVING THE SAID WEST LINE AND WITH THE NORTH LINE OF THE SAID TIMOTHY E.
