of 130.98 feet to an existing stone; thence north 06 degrees 26 minutes
east along the easterly line of the C.A. and C.R.R. a distance of
57.60 feet to an existing stone; thence south 02 degrees 20 minutes
east along the southerly line of lands now or formerly owned by R.
Grieves and recorded in deed book 482, page 563 of the deed records
of said county a distance of 133.90 feet to a point; thence south 09
degrees 37 minutes west along the westerly right of way line of Lake

hunderths of an acre more or less.


