LEGAL DESCRIPTION
For Quadran Company

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being part of Outlot No. 21 of the Town of Putnam, as recorded in Deed Book A, page 6 of the Muskingum County Records, and being all those lands intended to be described in Deed Volume 577, page 176; being further bounded and described as follows:

Beginning at a magnetic nail set in a concrete wall at the northeast corner of said Outlot 21, thence, south 00 degrees – 00 minutes – 00 seconds east, 89.85 feet, along the west line of Woodlawn Avenue, to a magnetic nail set;

Thence, leaving Woodlawn Avenue and along the north line of those lands now or formerly owned by Robert M. Daniels (2186/833), north 89 degrees – 56 minutes – 49 seconds west, 140.00 feet to an iron pin found on the east line of a 16½ foot alley;

Thence, north 00 degrees – 00 minutes – 00 seconds east, 89.85 feet, along said alley, to a railroad spike set on the south line of Washington Street;

Thence, south 89 degrees – 56 minutes – 49 seconds east, 140.00 feet, along said street, to the ***point of beginning***, and ***containing 0.289 acres more or less.***

Subject to all legal highways and easements, whether recorded or implied.


