BEGINNING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHWEST CORNER OF OUTLOT 4 OF FAIR OAKS SUBDIVISION AS RECORDED IN PLAT BOOK 2, PAGE 35 OF THE MUSKINGUM COUNTY PLAT RECORDS, SAID POINT ALSO BEING AT THE INTERSECTION OF THE NORTH LINE OF CLEVELAND STREET (VACATED) AND THE EAST LINE OF MOXAHALA AVENUE; THENCE WITH THE SOUTH LINE OF SAID OUTLOT 4, NORTH 88 DEGREES 55 MINUTES 06 SECONDS EAST 459.45 FEET TO A POINT AT THE LOW WATER LINE OF THE MUSKINGUM RIVER, PASSING AN IRON PIN SET AT 335.75 FEET; THENCE WITH THE SAID LOW WATER LINE THE NEXT EIGHT COURSES AND DISTANCES:

 - 7) SOUTH 00 DEGREES 22 MINUTES 51 SECONDS WEST 176.42 FEET TO A POINT;
 - 8) SOUTH 00 DEGREES 58 MINUTES 48 SECONDS WEST 176.82 FEET TO A POINT
- ON THE NORTH RIGHT-OF-WAY LINE OF SR 555 (1975 SURVEY) AT 110 FEET LEFT OF CENTERLINE STATION 558+93.88; THENCE LEAVING THE SAID LOW WATER LINE AND WITH THE SAID RIGHT-OF-WAY LINE, SOUTH 89 DEGREES 02 MINUTES 01 SECONDS WEST 393.88 FEET TO A POINT AT 110 FEET LEFT OF CENTERLINE STATION 555+00, PASSING AN IRON PIN SET AT 35.00 FEET; THENCE CONTINUING WITH THE SAID RIGHT-OF-WAY LINE, NORTH 64 DEGREES 50 MINUTES 43 SECONDS WEST 62.35 FEET TO A POINT AT 137.45 FEET LEFT OF CENTERLINE STATION 554+44.02, SAID POINT BEING ON THE EAST RIGHT-OF-WAY LINE OF RELOCATED COUNTY ROAD NUMBER 6; THENCE WITH THE RIGHT-OF-WAY OF SAID COUNTY ROAD NUMBER 6, NORTH 04 DEGREES 02 MINUTES 07 SECONDS WEST 235.06 FEET TO AN IRON PIN SET AT 71.08 FEET LEFT OF CENTERLINE STATION 8+23.35; THENCE NORTH 01 DEGREES 01 MINUTES 44 SECONDS WEST 843.18 FEET ALONG THE SAID EAST RIGHT-OF-WAY TO THE PLACE OF BEGINNING.
