## LEGAL DESCRIPTION FOR MILLER LOGGING

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING LOT #3 OF COYLE'S SUBDIVISION AS RECORDED IN PLAT BOOK #1, PAGE 285, AND ALSO BEING PART OF THE EAST PART OF FRACTIONAL SECTION 6, TOWNSHIP 12, RANGE 13. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF SAID LOT #3, THE TRUE POINT OF BEGINNING FOR THIS PARCEL, THENCE, SOUTH 82 DEGREES - 30 MINUTES - 00 SECONDS EAST, 191.79 FEET TO A POINT IN THE CENTER OF ARCADIA LANE (PRESENT LOCATION); THENCE, CONTINUING SOUTH 82 DEGREES - 30 MINUTES - 00 SECONDS EAST, 352.04 FEET TO A POINT IN SAID LANE; THENCE, ALONG THE CENTER THEREOF, THE FOLLOWING FIVE COURSES AND DISTANCES:

- A) SOUTH 67 DEGREES - 20 MINUTES - 35 SECONDS EAST, 39.29 FEET TO A POINT.
- B) SOUTH 68 DEGREES - 08 MINUTES - 00 SECONDS EAST, 49.93 FEET TO A POINT.
- C) SOUTH 69 DEGREES - 04 MINUTES - 17 SECONDS EAST, 49.63 FEET TO A POINT.
- D) SOUTH 69 DEGREES - 44 MINUTES - 27 SECONDS EAST, 210.14 FEET TO A POINT.
- E) SOUTH 70 DEGREES - 11 MINUTES - 33 SECONDS EAST, 49.35 FEET TO A POINT.

THENCE, LEAVING ARCADIA LANE, NORTH 00 DEGREES - 01 MINUTES - 08 SECONDS EAST, 790.29 FEET TO AN IRON PIN SET AT THE NORTHEAST CORNER OF SAID LOT #3, PASSING AN IRON PIN SET AT 20.00 FEET; THENCE, SOUTH 85 DEGREES - 24 MINUTES - 23 SECONDS WEST, 914.89 FEET TO AN IRON PIN FOUND AT THE NORTHWEST CORNER OF SAID LOT #3 AT THE EAST LINE OF DULTY STREET; THENCE, SOUTH 00 DEGREES - 00 MINUTES - 06 SECONDS WEST, 505.09 FEET TO THE POINT OF BEGINNING AND CONTAINING 13.003 ACRES MORE OR LESS, OF WHICH 12.596 ACRES LIES IN LOT #3 AND 0.407 AC. LIES IN FRAC. SECTION #6.


