Beginning for reference and the principal place of beginning, at an iron pin set on the northwest corner of Lot 18 of Mornington Subdivision, (Pl. Bk. 2, Pg. 84);

Thence along the south line of Wheeler Road, and the north line of said Lot 18, South 35 degrees 49 minutes 38 seconds East, 36.50 feet to an iron pin set on the northwest corner of a vacated portion of Haessler Street;

Thence continuing along the south line of said Wheeler Road, South 42 degrees 08 minutes 11 seconds East, 88.49 feet to an iron pin set on the northwest corner of lands presently owned by the Zanesville Metropolitan Housing Inc.,(DR 881-92), from which a 3/8" diameter iron pin found bears South 42 degrees 08 minutes 11 seconds East, 5.39 feet;

Thence along the lines of said Metropolitan Housing lands the following two courses:

- 1.) South 21 degrees 46 minutes 34 seconds West, 171.00 feet to an iron pin set, passing a 3/8" diameter iron pin found at 46.53 feet, and perpendicularly offline to the northwest 1.18 feet;
- 2.) North 34 degrees 16 minutes 47 seconds West, 48.00 feet to a point in a ten inch diameter wild cherry tree, on the east line of Haessler Street, from which a 3/8" diameter iron pin found bears North 50 degrees 54 minutes 40 seconds West, 6.62 feet;

Thence along the east line of said street, North 20 degrees 38 minutes 10 seconds East, 45.47 feet to an iron pin set on the southeast corner of the vacated portion of said street;

Thence along the south line of said vacated portion, the north line of Stone Street, and the south line of said Lot 18, North 42 degrees 18 minutes 02 seconds West, 144.43 feet to an iron pin set on the southwest corner of said Lot 18;




