Situated in the City of Zanesville, Muskingum County, Ohio. Being part of lots 5, 6, 7, and 8 in Square 3 of the town Plat of Zanesville (D.B. "E" Pg. 444), and being described as follows:

Beginning at the Northeast corner of lot 5 of the town plat of Zanesville, being referenced by a set rebar bearing N.90°00'00"E. a distance of 2.00 feet;

Thence, S.00°00'00"W. a distance of **191.58 feet** along the West line of Second Street a set rebar on the North line OF a 20 foot wide rail road spur;

Thence, on a curve to the right an arc distance of 156.25 feet, on a radius of 166.05 feet, whose cord bears S.62°30'13"W. a distance of **150.55 feet** along said spur to a chiseled "X" on the East line of an alley;

Thence, N.00°00'00"E. a distance of **129.09 feet** along the east line of said alley to a point on the Northwest corner of Lot 7;

Thence, N.90°00'00"E. a distance of **42.80 feet** along the North line of said lot to a point;

Thence, N.18°42'17"E. a distance of **14.78 feet** along the east line of the Lands, now or formerly, owned by the American Light Company (323/327) to a set P.K. nail;

Thence, N.00°00'00"E. a distance of **118.00 feet** along the east line of said Light lands to a set rebar on the South line of Main Street;

Thence, N.90°00'00"E. a distance of **86.00 feet** along the South line of Main Street to the point of beginning.

The above described parcel contains **0.59 acres**, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

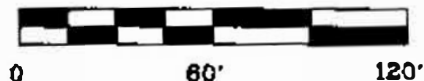

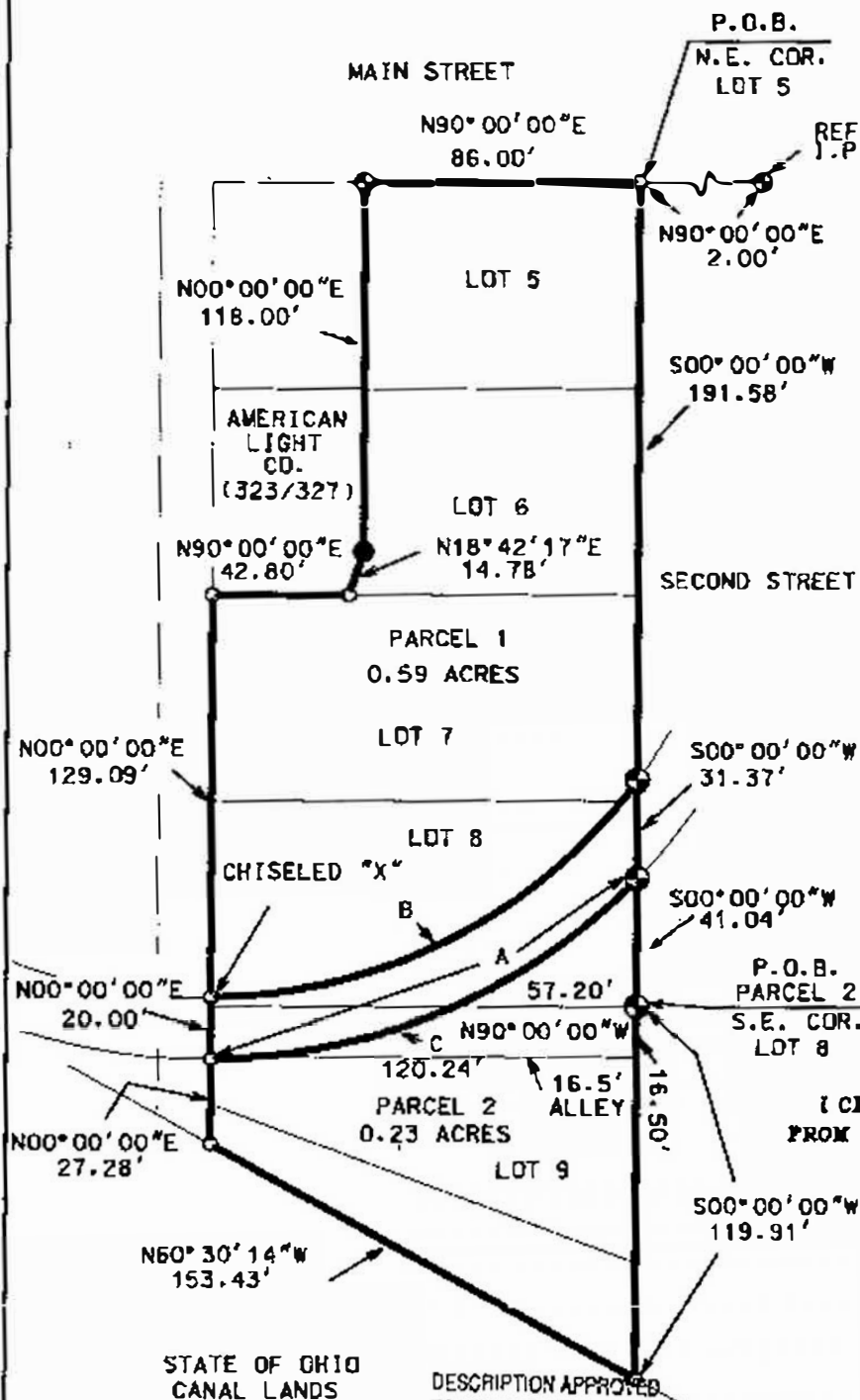
