DESCRIPTION FOR CONVEYANCE
 Premises at 633 Merrick Avenue, Zanesville, Ohio

Situated in the County of Muskingum, in the State of Ohio, and in the City of Zanesville, and bounded and described as follows:

Commencing for reference at the point of intersection of the West line of Maysville Avenue and the North line of Merrick Avenue in said City; thence run West along and upon the North line of Merrick Avenue a distance of 177.8 feet (by deed) to an iron pin (rebar) found at the Southwest corner of the land conveyed to Alice V. Moody by deed recorded in Book 904, Page 299, of the Deed Records of said County; thence continue West along and upon the North line of Merrick Avenue a distance of 620.00 feet to an iron pin (rebar) set at the True Place of Beginning of the premises herein intended to be described; thence continue West along and upon the North line of Merrick Avenue a distance of 40.00 feet to an iron pin (rebar) set; thence run North on a line at right angles with said last mentioned line a distance of 132.00 feet to an iron pin (rebar) set on the South side of an alley beside an old bent iron pipe; thence run East on the South side of said alley a distance of 40.00 feet to an iron pin (rebar) set; thence run South a distance of 132.00 feet to the True Place of Beginning, containing 0.12 acre, more or less. (Being known as Lot No. 13 of an unrecorded plat of a subdivision of the property of L. C. Merrick and Mary A. Ayers dated March 28, 1904; Excepting from said Lot No. 13, a strip 10 feet in width extending along the entire East side thereof.)

Being a new survey of those premises conveyed to Gloria J. Englehart by deed recorded in Vol. 446, Page 3, of the Muskingum County Deed Records, and being all of Muskingum County Auditor's Parcel No. 80-82-13-04-40-000.

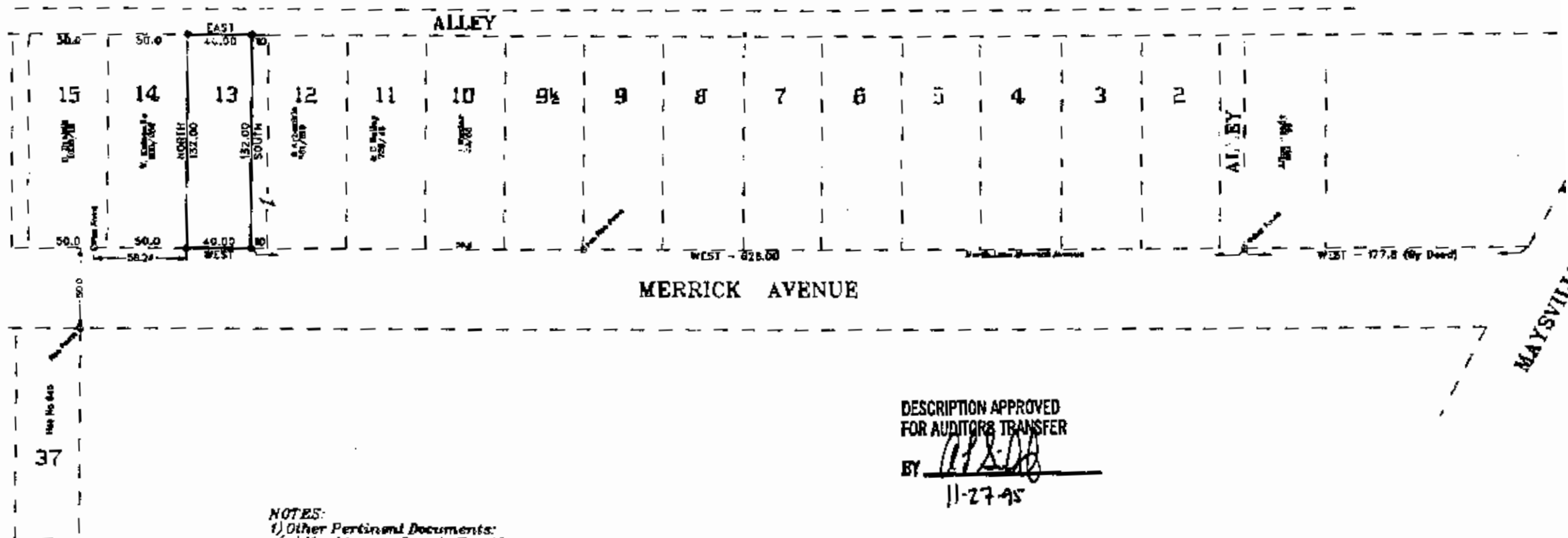
