ALL OF AUDITORS PARCEL
82-14-01-06-000 (0.183 Acres)

Situated in the City of Zanesville, Muskingum County, Ohio. Being lots 24 and 25 of Spence Addition^{P.S. 713} as conveyed in Deed Book 1682 Page 45 of the Muskingum County Deed records and being described as follows:

Beginning at an iron pin found in the Southeast corner of Lot 23 of Spence Addition;

Thence, **N.03°57'20"E.** a distance of **99.01** feet along the East line of said Lot to a set rebar on the South line of a 10' alley;

Thence, **S.86°02'40"E.** a distance of **87.30** feet along said alley to a set rebar;

Thence, **S.19°23'44"W.** a distance of **126.30** feet along said alley to a set Rebar on the North line of Spence Avenue;

Thence, **N.63°05'20"W.** a distance of **58.29** feet along said Avenue to the point of beginning.

The above described parcel contains 0.183 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


