Beginning at an iron pin set at the northwest corner of Lot 203 also being on the south line of an alley 16 feet in with, thence with the south line of said alley, N77°04'20"E, a distance of 38.68 feet to railroad spike found on the northwest corner of the lands now owned by Thomas & Faith Bash (OR 2632-

thence leaving the south line of said alley and going with the common line of said Morehouse/Bash's lands the following two (2) courses:

1. S10°51'51"E, a distance of 101.48 feet to an iron pin found;

2. S07°02'04"E, a distance of 49.72 feet to an iron pin found on the north line of Pershing Road, also being the southwest corner of said Bash's lands:

thence with the north line of said Pershing Road, S77°04'20"W, a distance of 74.21 feet to a pipe found on the southwest corner of said Lot 203;

thence leaving the north line of said Pershing Road and going with the common line of said Lot 203 and Lot 204, N03°25'51"E, a distance of 157.24 feet to the place of beginning, containing 0.199 acres more or less, subject to all legal highways and easements of record.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.




