First Parcel Being the north half of Lot 6 of Buckingham and Potwins Addition as the same is designated and delineated in the Muskingum County Plat Records Book 1, Page 218 and being a part of the same premises described in the Mus. again county Deed Records, Volume 718, Page 283; beginning for reference at an iron and the intersection of the east line of Summit Street and the east lin Street; thence along the east line of Whipple Street North 2 degrees 25 minutes East 125.40 feet to an iron pin found and the principal place of beginning; thence continuing along the east line of Whipple Street North 2 degrees 25 minutes East 51.15 feet to a point at the northwest corner of Lot 6; thence along the north line of Lot 6 North 75 degrees 00 minutes 00 seconds East 192.86 feet to a point at the northeast corner of Lot 6; thence along the east line of Lot 6 South 15 degrees 45 minutes East 47.62 feet to a point; thence South 74 degrees 40 minutes 24 seconds West 208.79 feet to the principal place of beginning, containing 0.22 acres, more or less, subject to all legal highways and easements. 83-67-61-09-
