Being all of the prior deed reference Volume 1037, Page 288 of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 80-83-16-02-02-000, and more particularly described as follows;

Commencing at at the Southeast corner of Lot #40 of Millwood Subdivision as recorded in Plat Book 1, Page 24, also being the intersection for the West line of Mead Street in the City of Zanesville and the North line of a 14.42 acre tract as conveyed to Willis Bailey by Edward Matthews as described in deed reference Volume 94, Pages 584 and 585, said 14.42 acre tract being part of a plat recorded in Plat Book 1, Page 88; thence S 04 05 44 W 240.00 feet along the West line of said Mead Street to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- thence S 04 05 44 W 40.00 feet continuing along the West line of said Mead Street to an iron pin (set);
- #2- thence N 85 54 16 W 130.00 feet along a common line with the M Scoles property also being part of said 14.42 acre tract, to an iron pin (set) on the East line of a 15 foot wide alley as described in said prior deed reference Volume 1037, Page 288;
- #3- thence N 04 05 44 E 40.00 feet along the East line of said alley to an iron pin (set);
- #4- thence S 85 54 16 E 130.00 feet along a common line of the D & R Dillion property also being part of said 14.42 acre tract, to the place of beginning containing 0.119 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).




