to an iron pin set; thence leaving Carter's line North $3^{\circ} 13' 00''$ West
along Parcel Two 118.75 feet to an iron pipe found; thence continuing
along Parcel Two North $30^{\circ} 38' 00''$ West 30.36 feet to an iron pipe found
on the South line of Ridge Avenue; thence along Ridge Avenue North
 $57^{\circ} 00' 00''$ East 51.30 feet to the place of beginning, containing 0.10
acres more or less. *Being all of 83-17-02-01*

South $30^{\circ} 38' 00''$ East 30.36 feet to an iron pipe found and South
 $3^{\circ} 13' 00''$ East 118.75 feet to an iron pin set; thence South $88^{\circ} 30'$
 $56''$ West 43.50 feet along Ruth Carter, Vol. 560, Page 504, to an iron
pin set; thence leaving Carter's line and along R. & J. Brennan,
Vol. 980, Page 350, North $7^{\circ} 44' 11''$ West 122.36 feet to an iron pipe
found (excepting a 5.00 wide strip along this line as half of a 10.00
wide right-of-way easement to both parties); thence along Ridge Avenue
North $57^{\circ} 00' 00''$ East 45.10 feet to the place of beginning, containing
0.15 acres more or less.

Bearings are based on Ridge Avenue bearing North $57^{\circ} 00' 00''$ East.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic

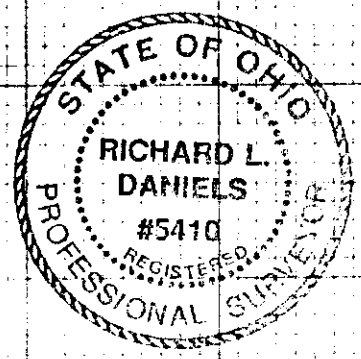
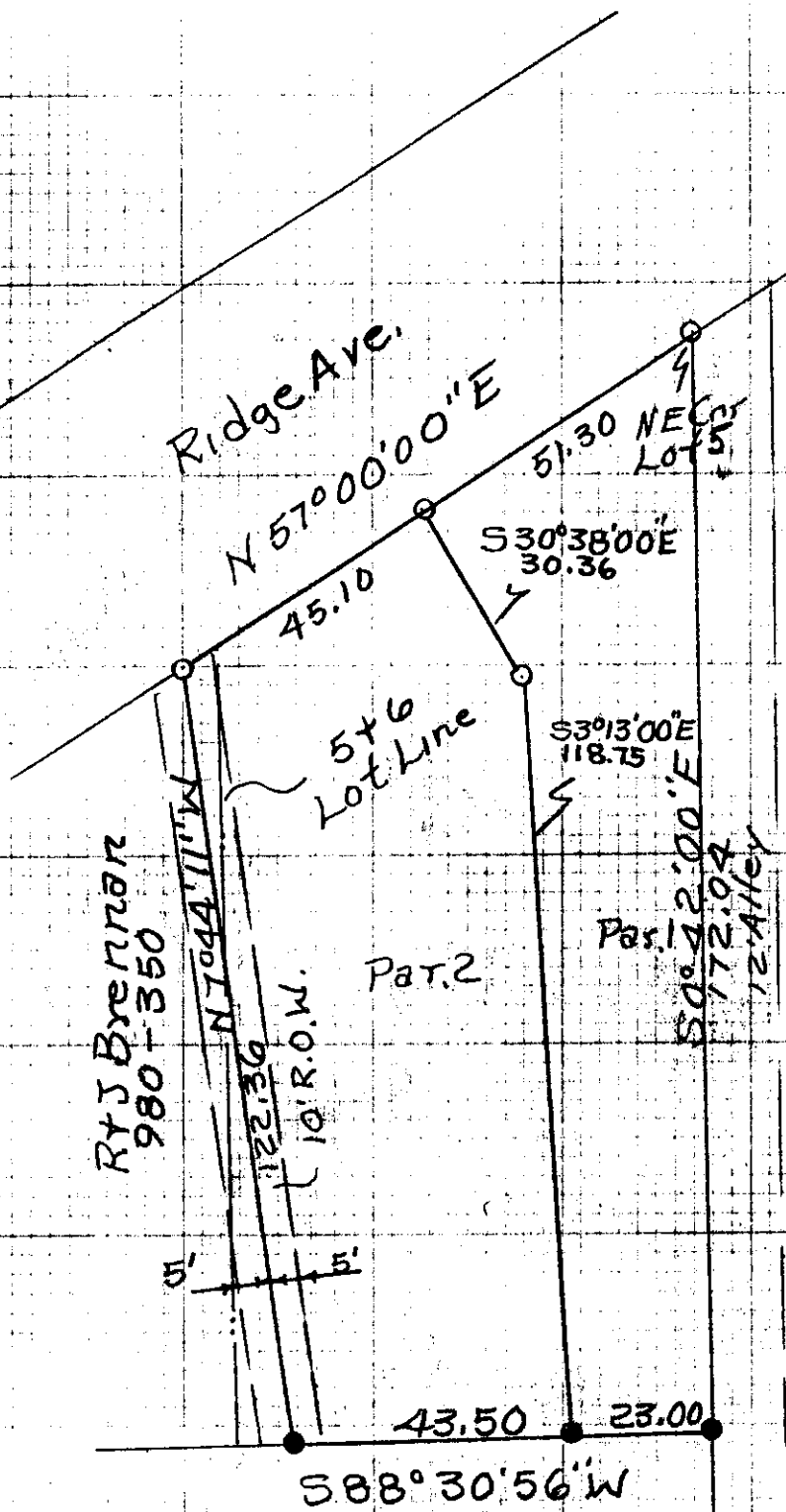
