BEING A PART OF 14.42 ACRE TRACT CONVEYED TO WILLIS BAILEY BY EDWARD MATTHEWS BY DEED DATED MAY 9, 1890, AND RECORDED IN MUSKINGUM COUNTY DEED BOOK 94 PAGE 584 AND 585 AS SAID 14.42 ACRE TRACT OF LAND IS DELINEATED ON A PLAT OF THE ESTATE OF DR. I. MATTHEWS, MARKED "EDWARD MATTHEWS", RECORDED IN BOOK OF PLATS NUMBER 1 PAGE 88 OF THE PLAT RECORDS OF SAID COUNTY, IN THE CITY OF ZANESVILLE, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET MARKING THE INTERSECTION OF THE NORTH LINE OF CLOVER STREET AND THE EAST LINE OF MEAD STREET; THENCE NORTH 00 DEGREES 13 MINUTES 46 SECONDS WEST 65.00 FEET ALONG THE EAST LINE OF MEAD STREET TO AN IRON PIN SET; THENCE NORTH 89 DEGREES 58 MINUTES 17 SECONDS EAST 70.00 FEET ALONG THE SOUTH LINE OF A TRACT CONVEYED TO J. AND A. GRIMES BY DEED RECORDED IN DEED BOOK VOLUME 509, PAGE 479 OF THE MUSKINGUM COUNTY DEED RECORDS TO AN IRON PIN SET; THENCE SOUTH 00 DEGREES 13 MINUTES 46 SECONDS EAST 65.00 FEET ALONG THE WEST LINE OF A TRACT CONVEYED TO R. AND B. MONTGOMERY BY DEED RECORDED IN DEED BOOK VOLUME 512 PAGE 537 TO AN EXISTING P.K. NAIL; THENCE SOUTH 89 DEGREES 58 MINUTES 17 SECONDS WEST 70.00 FEET ALONG THE NORTH LINE OF CLOVER STREET TO THE PLACE OF BEGINNING.

CONTAINING 0.105 MORE OR LESS ACRES, SUBJECT TO ALL APPLICABLE EASEMENTS.

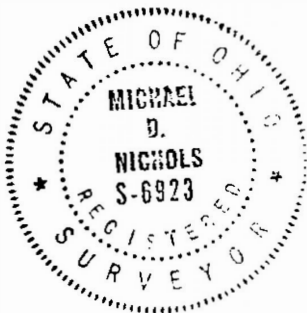

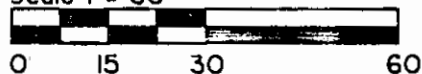

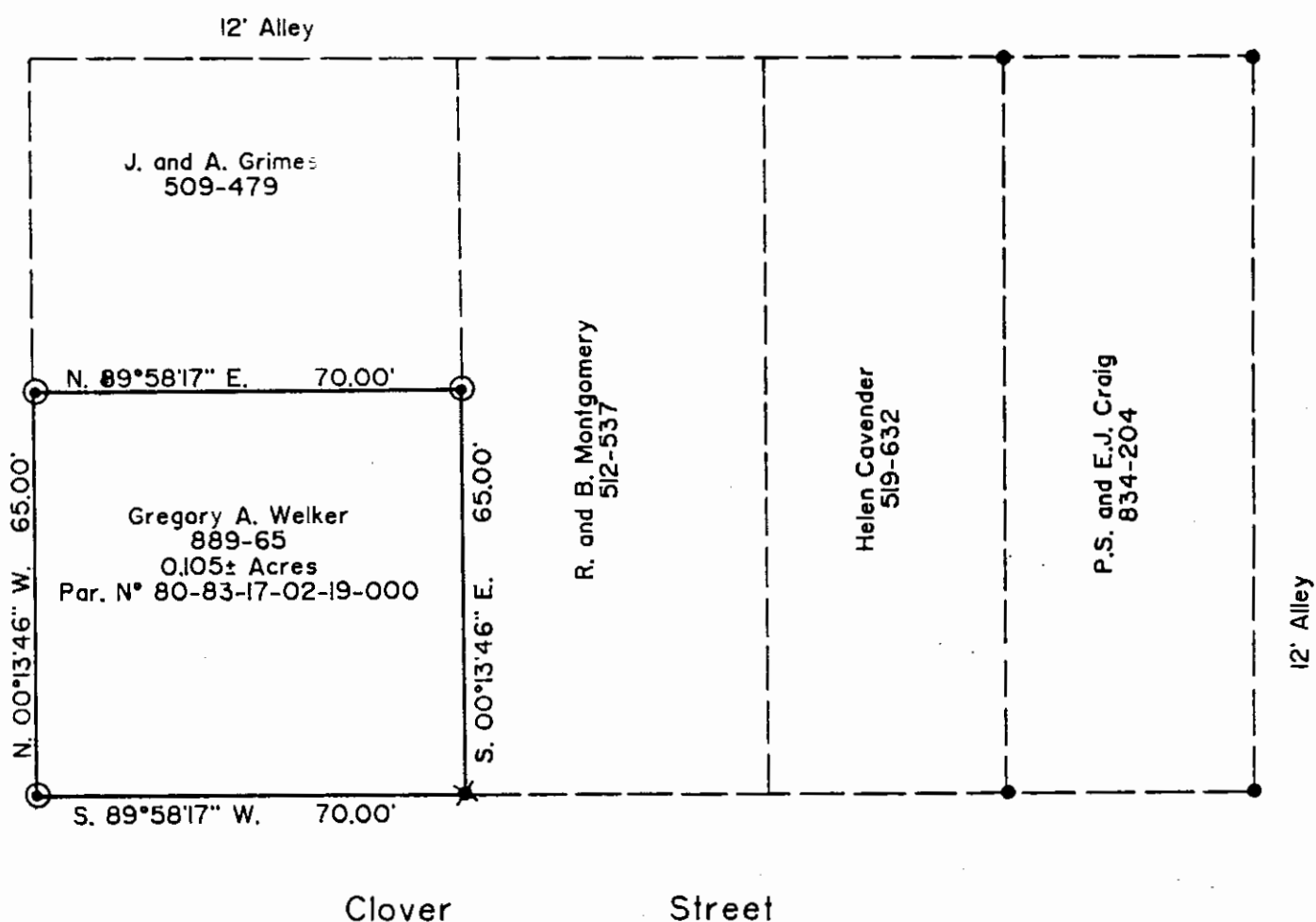


- ⊙ Iron pin set ( $\frac{5}{8}$ " rebar / 10. cap)

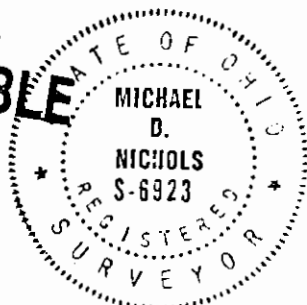
