NORRIS BY DEED RECORDED IN VOLUME 1080, PAGE 649 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE WITH THE WEST LINE OF LUCK AVENUE, SOUTH 03 DEGREES 30 MINUTES 00 SECONDS WEST 40.03 FEET TO A POINT; THENCE LEAVING THE SAID STREET WITH THE SOUTH LINE OF SAID LOT NUMBER TWELVE, NORTH 86 DEGREES 17 MINUTES 53 SECONDS WEST 140.00 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 2.00 FEET; THENCE WITH THE EAST LINE OF A 16 FOOT ALLEY, NORTH 03 DEGREES 30 MINUTES 00 SECONDS EAST 40.03 FEET TO AN IRON PIN SET; THENCE LEAVING THE SAID ALLEY WITH THE NORTH LINE OF SAID LOT TWELVE, SOUTH 86 DEGREES 17 MINUTES 53 SECONDS EAST 140.00 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 138.00 FEET.

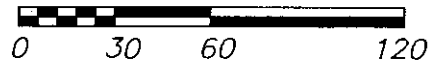
