Situated in the State of Ohio, County of Muskingum, being Lot 9 and part of Lot 10 in Sullivan's Addition to the Town of Putnam in the 5th Ward of the City of Zanesville as delineated in P.B. 1 Page 195, and as conveyed to **Habitat for Humanity of Southeast Ohio** in Official Record 2955 Page 773 at the Muskingum County Recorder's Office and being more particularly described as follows;

Commencing at an iron rebar found (capped C.R. Harkness) on the northeast corner of Lot 16 of said Sullivan's Addition, said iron rebar also being on the south line of Lorain Street (Hull Street) 43.5 feet wide, thence **South 00 degrees 27 minutes 10 seconds West** along the west line of Columbia Street (Pierce Street) 39.0 feet wide, a distance of **183.75 feet** to an iron pin set (capped TRIUMPH SERVICES) on the northeast corner of Lot 11 from which an iron pin found bears **South 23 degrees 43 minutes 47 seconds East** a distance of **2.91 feet**.

Thence **South 00 degrees 27 minutes 10 seconds West**, with the west line of said Columbia Street and the east line of said Lot 11 and Lot 10, a distance of **55.12 feet** to an iron pin set (capped TRIUMPH SERVICES); **Principal Point of Beginning**;

Thence continuing with said lines, **South 00 degrees 27 minutes 10 seconds West**, a distance of **55.12 feet** to an iron pin set (capped TRIUMPH SERVICES) at the southeast corner of Lot 9.

Thence with the north line of Woodruff Alley 16.0 feet wide and the south line of Lot 9, **North 89 degrees 32 minutes 52 seconds West** a distance of **116.57 feet** to an iron pin set (capped TRIUMPH SERVICES) at the southwest corner of said Lot 9.

Thence with the east line of a 16.0 feet wide alley and the west line of Lot 9 and Lot 10, **North 00 degrees 27 minutes 10 seconds East** a distance of **55.12 feet** to an iron pin set (capped TRIUMPH SERVICES).

Thence with a new division line through the lands of now or formerly **Habitat for Humanity of Southeast Ohio** as recorded in Official Record 2955 Page 773, also known as Lot 10 of Sullivan's Addition, **South 89 degrees 32 minutes 52 seconds East** a distance of **116.57 feet** to the **Principal Point of Beginning**.

Being **0.0983-acres** in all of Muskingum County Auditor's Tax Parcel Number 83-22-03-11-000 & **0.0492-acres** in Part of P.N. 83-22-03-12-000, totaling **0.1475 Ac.**
