ward, new third ward, bounded and described as follows:

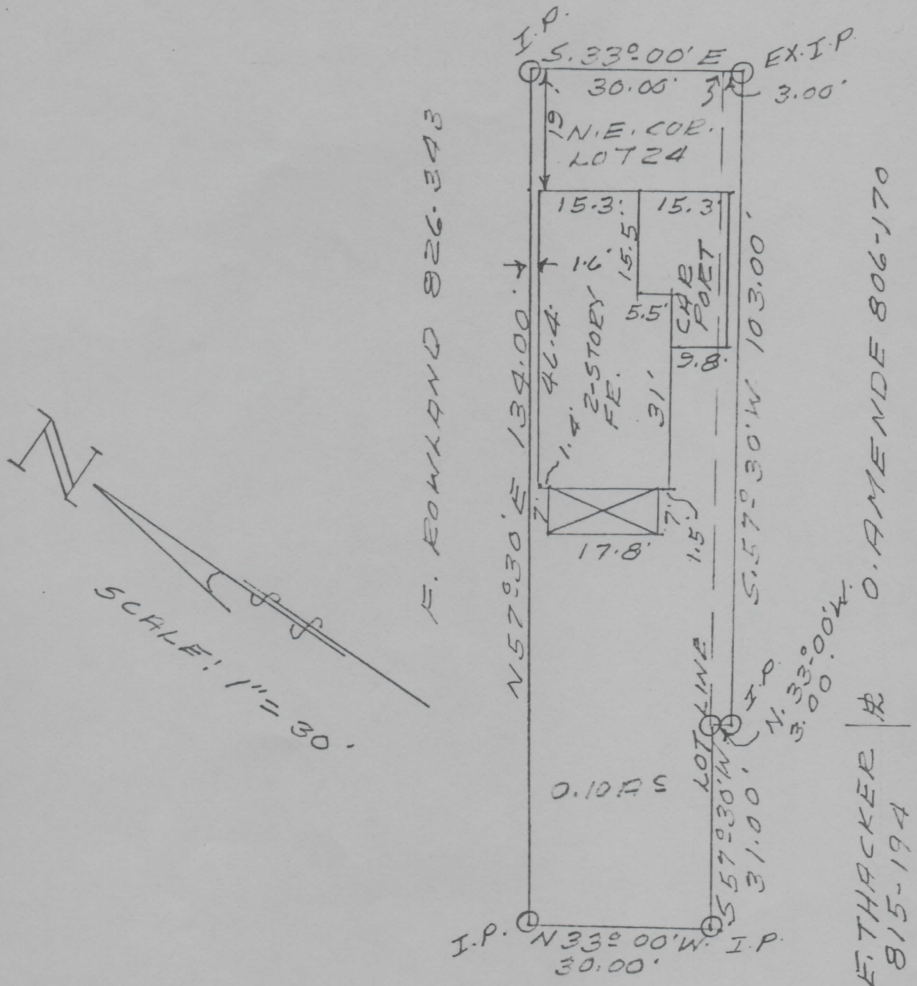
Beginning at the northeast corner of lot 24 in Chapmans Addition
