

DESCRIPTION OF SURVEY FOR WILBERT C. NABB

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being all of the prior deed reference Volume 959, Page 195, of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 80-83-27-05-31-000, and more particularly described as follows;

- Commencing at the intersection of the Northeastern line of Chapman Street and the Northwestern line of Ridge Avenue; thence along the Northwestern line of Ridge Avenue (as surveyed by John R. Marshall RS #5307 and described in said prior deed reference) N 46 41 59 E 261.00 feet to an iron pin (found) at the place of beginning for the property herein intended to be described;
- #1- thence N 39 59 44 W 243.74 feet to an iron pin (set) on the South line of a 1 foot wide strip, reserved on the Plat of Hissey Place as recorded in Plat Book 4, Page 25;
 - #2- thence along the South line of said 1 foot reserved strip S 87 45 28 E 54.46 feet to the West line of the property described in deed reference Volume 903, Page 148, from which an iron pipe (found) on said line for reference bears N 40 10 00 W 0.52 feet;
 - #3- thence along the West line of said Volume 903, Page 148 S 40 10 00 E 204.77 feet to an iron pin (found) on the Northwestern line of Ridge Avenue;
 - #4- thence along the Northwestern line of Ridge Avenue S 46 41 59 W 41.00 feet to the place of beginning, containing 0.209 acres.

The bearings within this description are based on the East line of the prior deed reference as Surveyed by John R. Marshall RS #5307, and completed on November 11, 1982. Bearings are shown in a format of Degrees, Minutes, & Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

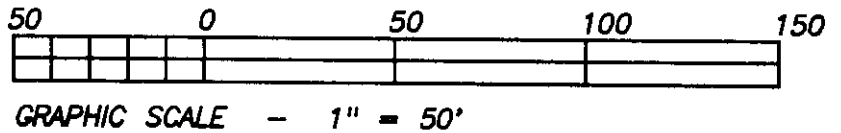
SURVEY PLAT FOR WILBERT C. NABB
