COMMENCING AT THE NORTHEAST CORNER OF LOT 53 OF SAID WEST ZANESVILLE;

THENCE WITH THE WEST LINE OF G. W. MORSE STREET (FORMERLY AMELIA STREET), NORTH 28 DEGREES 18 MINUTES 00 SECONDS EAST 25.00 FEET TO A POINT AT THE SOUTHEAST CORNER OF LOT 81;

THENCE WITH THE NORTH LINE OF AN ALLEY (SOUTH LINE OF SAID LOT 81 AND THE SOUTH LINE OF LOT 80), NORTH 61 DEGREES 37 MINUTES 13 SECONDS WEST 99.00 FEET TO AN IRON PIN SET), SAID IRON PIN BEING THE **PLACE OF BEGINNING** OF THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE NORTH LINE OF THE ALLEY (SOUTH LINE OF LOT 80, LOT 79, AND LOT 78), NORTH 61 DEGREES 37 MINUTES 13 SECONDS WEST 141.00 FEET TO AN IRON PIN SET ON THE EAST LINE OF A PARCEL CONVEYED TO THE WHEELING AND LAKE ERIE RAILROAD (DEED VOLUME 290, PAGE 7), PASSING AN EXISTING IRON PIN (1 INCH PIPE) AT 99.50 FEET;

THENCE LEAVING THE SAID NORTH LINE OF THE ALLEY AND WITH THE SAID EAST LINE OF THE RAILROAD PARCEL, NORTH 59 DEGREES 04 MINUTES 47 SECONDS EAST 164.15 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF JACKSON STREET (NORTH LINE OF LOT 79);
