thence along the East line of Lot No. 2 South  $38^{\circ} 45'$  West 80.00 feet  
to an iron pin set; thence North  $51^{\circ} 15'$  West 80.00 feet to the place

East 40.00 feet to an iron pin set at the Northeast corner of Lot  
Number 8; thence leaving alley South  $38^{\circ} 45'$  West along the West line  
of Lot Number 8 120.00 feet to the North line of Willow Street; thence  
along the North line of Willow Street North  $51^{\circ} 15'$  West 40.00 feet  
to the place of beginning, containing 0.110 acres more or less.

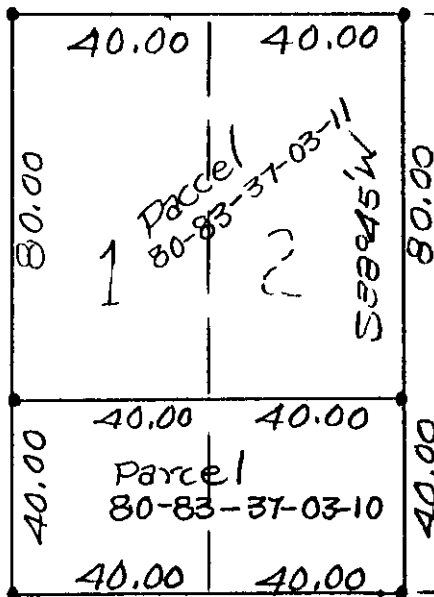

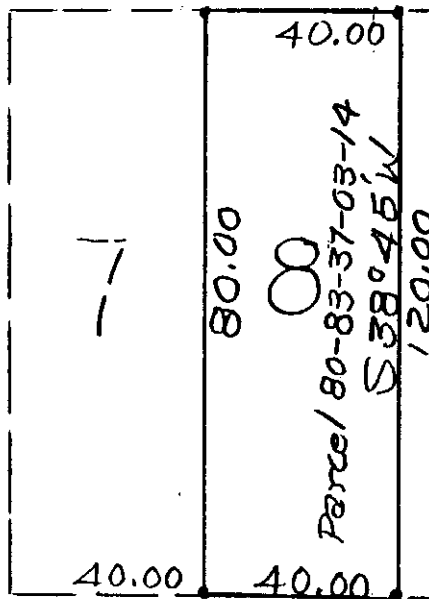
