Situated in the State of Ohio, County of Muskingum, City of Zanesville, bounded and described as follows:

Beginning for reference at the intersection of Forest Avenue and Blue Avenue as depicted on the Plat of Maplewood, as recorded in Muskingum County Plat Book 2, Page 45; thence North 40 degrees 52 minutes 30 seconds West 41.59 feet to an iron pipe found at the intersection of the west line of Blue Avenue and the north line of Forest Avenue; thence along said north line of Forest Avenue North 87 degrees 00 minutes 00 seconds West 295.00 feet to an axle found on the southwest corner of lands now owned by R.B. and R.H. Wolfe, Jr. (Deed Record 1037-496) and the principal place beginning; thence continuing with said line North 87 degrees 00 minutes 00 seconds West 97.49 feet to an axle found on the southeast corner of lands now owned by B. Cultice (Deed Record 912-37), passing an axle found at 92.03 feet, offset 1.05 feet; thence along Cultice's east line North 05 degrees 09 minutes 28 seconds East 237.00 feet to an iron pin set on the south line of lands now owned by Zanesville Board of Education (Deed Record 876-193); thence along said south line South 87 degrees 04 minutes 49 seconds East 97.50 feet to an axle found on the northwest corner of said Wolfe's lands; thence along Wolfe's west line South 05 degrees 09 minutes 32 seconds West 237.14 feet to the principal place of beginning, passing iron pins set at 75.37 feet and 143.55 feet; containing 0.53 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Iron pins set are 5/8" rebar with plastic identification caps.

Bearings are based on the centerline of Forest Avenue as depicted on the Plat of Maplewood, recorded in Muskingum Count Plat Book 2, Page 45.


