Situated in the State of Ohio, County of Muskingum, City of Zanesville, being part of Out Lot 8 of Mount Auburn Addition and all of the lands now owned by Evelyn Newell as recorded in DR 616-220 of the Muskingum County Recorders Office and more particularly described as follows.

Beginning at the intersection of the south line of Lindsay Avenue and the west line of Blue Avenue, thence going with the south line of said Lindsay Avenue, N86°46'47"W, a distance of 263.00 feet to an iron pin found and the principal place of beginning:

thence leaving said south line and going with the west line of the lands now owned by Reitha P. Altier (OR 1529-507), S03°28'28"W, a distance of 112.37 feet to an iron pin found on the common line of Out Lots 8 & 9;

thence with the common line of said Out Lots 8 & 9, S88°13'43"W, a distance of 50.44 feet to an iron pin found on the southeast corner of the lands now owned by 37 Properties, LLC (OR 2350-225);

thence with the east line of said 37 Properties, LLC's lands, N03°34'27"E, a distance of 116.76 feet to pk nail found in the western half of a shared driveway, said pk nail also being on the south line of said Lindsay Avenue;

thence with the south line of said Lindsay Avenue, S86°46'47"E, a distance of 50.02 feet to the point of beginning, containing a total of 0.132 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 0.132 acre parcel is based on a field survey made by McPeek Land Surveying, LLC on September 11<sup>th</sup> 2018.

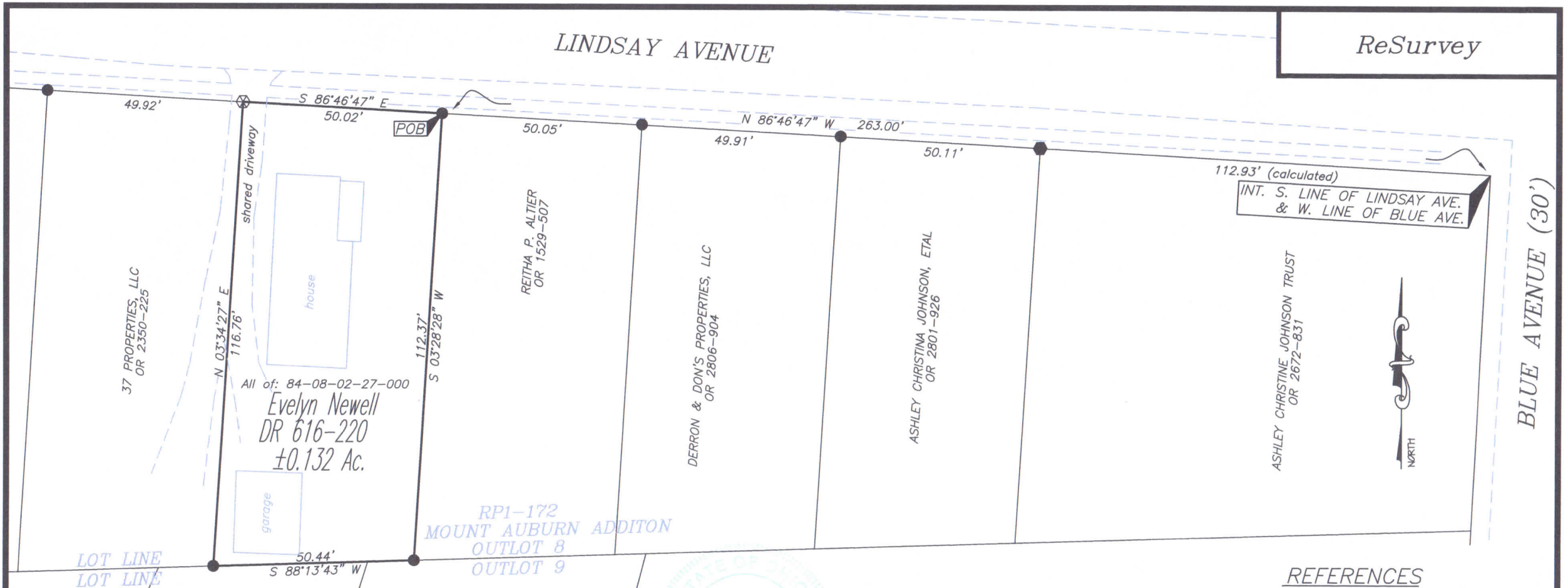

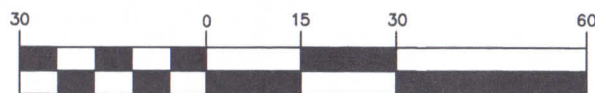
