## LEGAL DESCRIPTION FOR EMMA RITCHEY PROPERTY

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF McINTIRE TERRACE #1 AS RECORDED IN PLAT BOOK 1, PAGE 68, AND BEING ALL OF THOSE LANDS DESCRIBED IN DEED VOLUME 1096, PAGE 148, PARCEL #2, AND FURTHER BEING A PART OF LOT #22 OF SAID ADDITION; FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE NORTHWEST CORNER OF SAID LOT #22, THENCE, NORTH 52 DEGREES - 37 MINUTES - 29 SECONDS EAST, 121.42 FEET ALONG THE SOUTH LINE OF SUNSET AVENUE TO A STONE FOUND, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 52 DEGREES - 37 MINUTES - 29 SECONDS EAST, 58.62 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 37 DEGREES - 22 MINUTES - 31 SECONDS EAST, 160.68 FEET TO AN IRON PIN SET; THENCE, SOUTH 53 DEGREES - 16 MINUTES - 52 SECONDS WEST, 58.62 FEET TO AN IRON PIN SET; THENCE, NORTH 37 DEGREES - 22 MINUTES - 31 SECONDS WEST, 160.01 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.216 ACRES MORE OR LESS.



