## DESCRIPTION FOR CONVEYANCE

Premises at 932 Findley Ave., Zanesville, Ohio

Situated in the County of Muskingum, in the State of Ohio, and in the City of Zanesville, and bounded and described as follows:

Being a part of Lot No. 12 of McIntire Terrace, Plat No. 1 as recorded in the Recorder's Office of said Muskingum County in Plat Book 1, Page 68, and being more particularly described as follows:

Beginning at a point near the south side of Findley Avenue, 39.75 feet North 53 degrees 37 minutes East of an iron pin found at the northwest corner of said Lot No. 12 and on the north boundary thereof, said beginning point being marked by an iron pin (axle) found; thence continuing North 53 degrees 37 minutes East along the northerly line of Lot No. 12, a distance of 39.375 feet to a point; thence South 32 degrees 40 minutes East 115.00 feet to an iron pipe found; thence South 53 degrees 26 minutes 40 seconds West along the northerly line of the premises now or formerly owned by Tom V. Moorehead, Jr. (Deed Book 537, Page 812), a distance of 38.95 feet to an iron pin found; thence North 32 degrees 53 minutes West, parallel with the westerly line of said Lot No. 12, a distance of 115.09 feet to the place of beginning, containing 0.1032 acre, more or less.

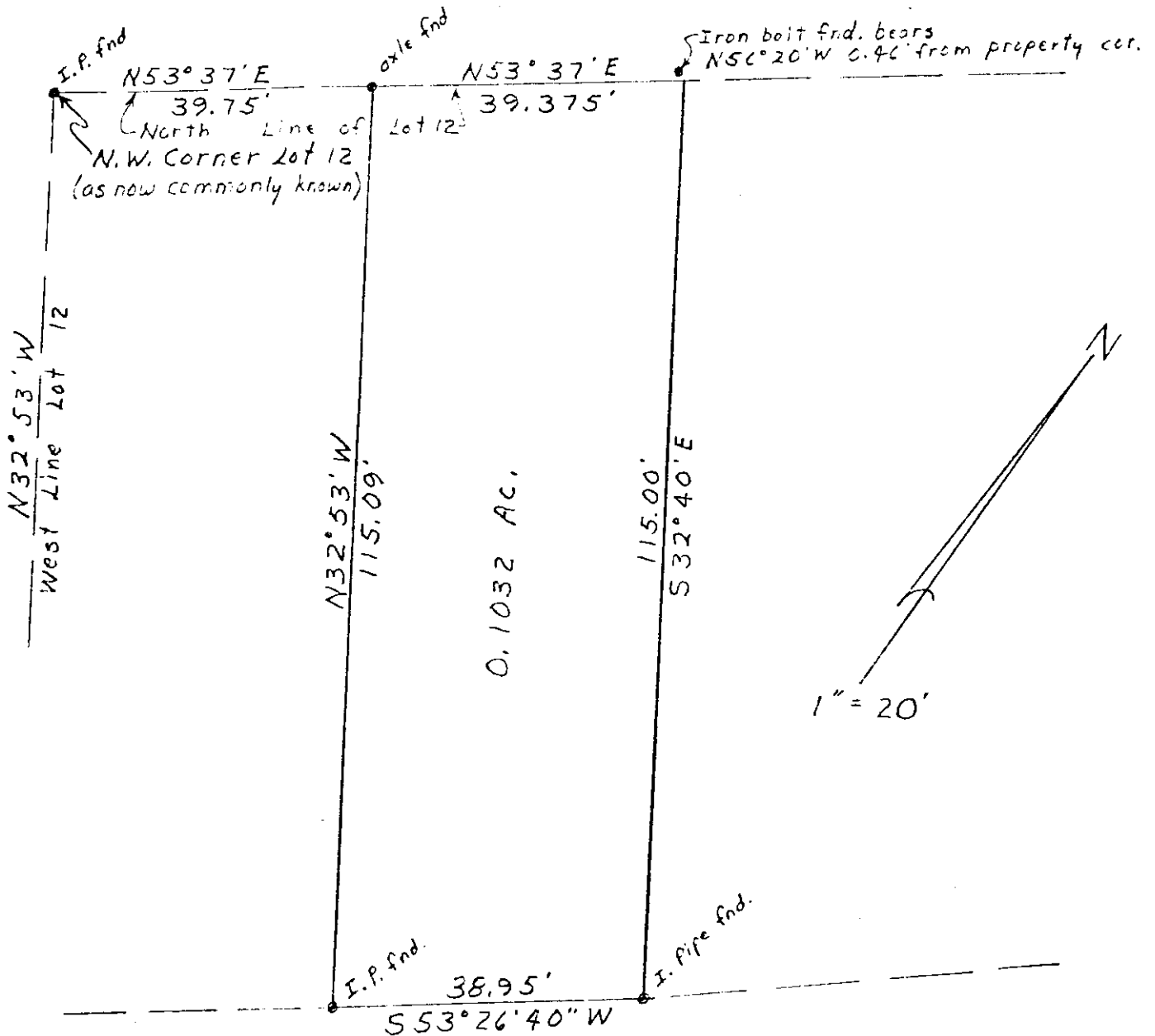
