**ALL OF AUDITORS PARCELS**

84-22-02-04-000 *1269 BLUFF ST*

Situated in the City of Zanesville, Muskingum County, Ohio. Being part of lots 6 and 8 and all of lot 7 in square 1 of Taylors Second Addition and being more particularly described as follows:

Beginning at the Southwest corner of Lot 7 in square 1 of Taylors Second Addition (P.B. 2, Pg. 4);

Thence, **N.25°54'46"E.** a distance of **83.75** feet along the East line of Miller Street to a point on the Southwest corner of the lands, now or formerly, owned by R. & E. Murphy (1118/489), passing the Southwest corner of lot 8 at 75.50';

Thence, **S.86°25'25"E.** a distance of **167.89** feet along the South line of said Murphy lands, and through lot 8, to a set rebar on the West line of Bluff Street, passing a set rebar at 5.00';

Thence, **S.25°00'00"W.** a distance of **92.50** feet along Bluff Street to a set rebar on the Northeast corner of the lands, now or formerly, owned by K. & L. VanHoughton (2017/683), passing the Northeast corner of Lot 7 at 8.25' and passing the Southeast corner of lot 7 at 83.50';

Thence, **N.83°26'36"W.** a distance of **166.16** feet along said VanHoughton lands, and through lot 6 to the point of beginning, passing a set rebar at 163.16'.

The above described parcel contains 0.32 acres, more or less and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

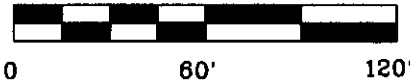
