DESCRIPTION OF SURVEY FOR MARK GILDOW

Situated in the State of Ohio, County of Muskingum, City of Zanesville, being in the Northwest quarter of Section 4, T-12, R-13, of the Congress Lands East of the Scioto River, also being part of the property described in Deed Book 817, Page-242 of said County Records, and is more particularly described as follows:

Commencing at the Southwest corner of Lot #22 in Elmwood Place, as delineated in Plat Book 5, Page-31 of said County Records; thence along a line as surveyed by, John R. Marshall, Surveyor #5307 and recorded in Deed Book 913, Page-21 of said County Records, N 83° 29' W (145.50) feet to an iron pin (found) at the Southwest corner of the property described in said Deed Book 913, Page-21; thence parallel with the centerline of Wheeling Ave., N 86° 14' 59" W (76.71) feet to an iron pin (set) under an existing chain-link fence; thence along said fence, N 3° 00' 03" E (2.16) feet to the place of beginning for the property herein intended to be conveyed; thence leaving said fence and along the North line of Wheeling Ave., N 80° 14' 59" W (49.71) feet to the Southwest corner of the grantors property and the East line of Gormley Alley, from said Southwest corner a iron pin (set) bears South (2.18) feet; thence leaving the North line of Wheeling Ave., and along the East line of Gormley Alley, North (125.00) feet to an iron pin (set); thence leaving the East line of Gormley Alley, S 80° 14' 59" E (51.65) feet to an iron pin (set): thence along the overhang of an existing garage, S 8° 53' 46" W (28.03) feet to an iron pin (set); thence S 84° 49' 07" E (7.50) feet to an iron pin (set) in line with said chain-link fence; thence along the extended line of said fence and then along said fence, S 3° 00' 03" W (96.44) feet to the place of beginning containing 0.146 acres.


