Beginning for reference and the principal place of beginning at an iron pin set at the northeast corner of Lot 31 of a plat of "William Fox Home Farm" (Plat Book 66, Page 353);

Thence along the west line of Fox Avenue, South 02 degrees 00 minutes 16 seconds West, 70.00 feet to an iron pin set on the north line of an alley;

Thence along the north line of said alley, North 87 degrees 59 minutes 44 seconds West, 84.27 feet to a PK Nail set in concrete, on the southeast corner of lands presently owned by J and D Property Rentals LTD,(OR 2084-45);

Thence along the lines of said J and D Rental lands, the following two courses:

- 1.) North 02 degrees 00 minutes 16 seconds East, 13.00 feet to an iron pin set;
- 2.) North 87 degrees 59 minutes 44 seconds West, 32.00 feet to an iron pin set on the east line of an alley;

Thence along the east line of said alley, North 02 degrees 00 minutes 16 seconds East, 57.00 feet to an iron pin set on the northwest corner of Lot 31, and the southwest corner of lands presently owned by Michael and Brandi L. Offineer, (OR 2342-375), passing an iron stake at 20.59 feet;

Thence along the north line of Lot 31, and the south line of said Offineer lands, South 87 degrees 59 minutes 44 seconds East, 116.27 feet to the principal place of beginning, containing 0.177 acres, more or less, and being all of Auditor's Parcel Numbers 84-28-01-14-000(+- 0.093 acres), and 84-28-01-15-000 (+- 0.084 acres).

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.




