Dunn's Addition, Plat Book 2, Page 148 thence; along the north line of Archer Avenue, South 86 degrees 28 minutes 25 seconds West 104.36 feet to an iron pin set, said point being the true point of beginning, thence; continuing along the north line of Archer Avenue, South 86 degrees 28 minutes 25 seconds West 115.64 feet to a PK-nail set, thence; leaving Archer Avenue and through the lands of The Downing Company, Deedbook 1150, Page 58, North 03 degrees 31 minutes 35 seconds West 80.98 feet to a PK-nail set, said point being in the south line of Greenwood Avenue (SR 22/US 40), thence; along the south line of Greenwood Avenue along a curve to the left having a radius of 9002.30 feet, a chord bearing of North 73 degrees 14 minutes 01 seconds East a chord length of 100.58 feet to a PK-nail set, said point being in the south line of Greenwood Avenue, thence; continuing along the south line of Greenwood Avenue, North 71 degrees 47 minutes 13 seconds East 18.33 feet to an iron pin set, thence; leaving the south line of Greenwood Avenue and through the lands of The Downing Company, South 03 degrees 31 minutes 35 seconds East 108.66 feet to an iron pin set, said point being the true place of beginning, containing 0.251 acres, more or less, with 0.016 acres being within the City of Zanesville and 0.235 acres being within Wayne Township.
