Situated In the County of Muskingum, In the State of Ohio, and In the City of Zanesville, and bounded and described as follows:
Being in the Third Quarter of Township One, Range Seven, and commencing, for reference, at a concrete monument found at the intersection of the West line of Galigher Street and the South line of Eastman Street in said City; thence run North 00 degrees 55 minutes 57 seconds West 47.15 feet to an iron pin (axle) found on the North line of Eastman Street; thence run North 87 degrees 41 minutes 32 seconds East along the Northerly line of Eastman Street 59.25 feet to an iron pin (axle) found; thence run North 87 degrees 30 minutes 51 seconds East along the Northerly line of Eastman Street 62.58 feet to an iron pin (rebar) set at the Place of Beginning of the premises herein intended to be described; thence run North 87 degrees 30 minutes 51 seconds East 51.00 feet to an iron pin (rebar) set on the Northerly line of Eastman Street and at the Southwest corner of the property now owned by Pauline Withers (Deed Book 1084, Page 345); thence run North 02 degrees 03 minutes 33 seconds West along the west line of said Withers land 188.38 feet to an iron pin (rebar) set at the Northwest corner of said Withers land; thence run South 87 degrees 34 minutes 45 seconds West 51.00 feet to an iron pin (rebar) set at the Northwest corner of these premises; thence run South 02 degrees 03 minutes 33 seconds East 188.44 feet to the Place of Beginning, containing 0.22 acre.
