DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, City of Zanesville, being a resurvey of Wanda L. Parsons Vol. 849 Pg. 15, and more particularly described as follows:

Beginning at a 5/8 inch Drill hole at the Northwest Corner of Lot 7 of Charles Meissner's Add. (Not Recorded), being at the Southeast Corner of Beulah Ave. (32' R/W) and Trilby Alley (16.50'); thence along the East line of Beulah Ave. South 00 Degrees 28 Minutes 45 Seconds East 141.59 feet to a 5/8 inch drilled hole in a retaining wall and the place of beginning; thence South 89 Degrees 12 Minutes 32 Seconds East 73.39 feet to an iron pin found; thence along the West line of a 9.00 foot alley South 02 Degrees 44 Minutes 29 Seconds East 50.81 feet to an iron pin set; thence South 89 Degrees 31 Minutes 15 Seconds West 75.38 feet to a 5/8 inch drilled hole in a retaining wall; thence along the East line of Beulah Ave. North 00 Degrees 28 Minutes 45 Seconds West 52.40 feet to the place of beginning, containing 0.09 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the East line of Beulah Ave. as being North 00 Degrees 28 Minutes 45 Seconds West.


