Beginning at an iron pin set on the easterly line of said Lot No. 49 bearing South 20 degrees 54 minutes West 363.58 feet from the Northeast corner of said Lot; thence continuing South 20 degrees 54 minutes West along the easterly line of Lot No. 49 a distance of 43.85 feet to an iron pin set at a corner of said Lot; thence South 48 degrees 00 minutes West along the Southeasterly line of said Lot 45.33 feet to an iron pin set; thence North 37 degrees 24 minutes West 70.60 feet to an iron pin set; thence North 70 degrees 50 minutes West 51.30 feet to an iron pin set on the westerly line of said Lot No. 49; thence North 20 degrees 54 minutes East along said westerly line 50.00 feet to an iron pin set; thence South 68 degrees 31 minutes East 132.00 feet to the Place of Beginning, containing 0.1793 acre.

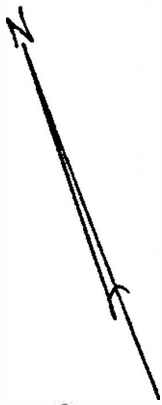

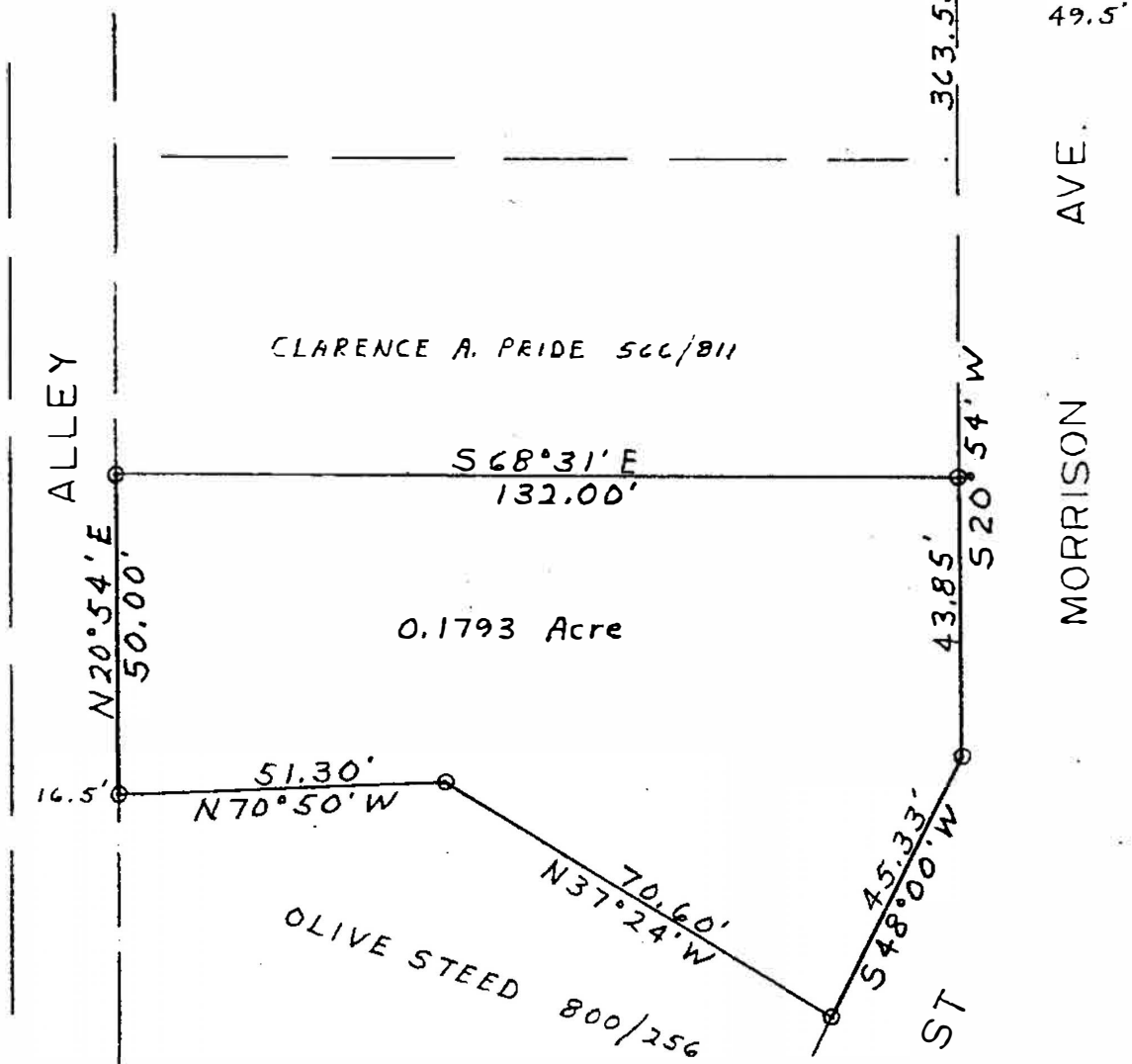
