

**NEW LEGAL

BEGINNING AT A CAPPED IRON PIN SET ON THE SOUTHERLY RIGHT OF WAY LINE OF HENRY STREET (28' WIDE) WITH THE EASTERLY RIGHT OF WAY LINE OF HAMLINE AVENUE (40' WIDE);


THENCE ALONG THE SOUTHERLY RIGHT OF WAY LINE OF HENRY STREET NORTH 89°56'43" EAST 174.26 FT. TO A 5/8" REBAR FOUND ON WESTERLY SIDE OF PRIVATE ALLEY (13' WIDE);

THENCE ALONG SAID ALLEY SOUTH 00°16'12" WEST 37.30 FT. TO A CAPPED IRON PIN SET;

THENCE SOUTH 89°56'43" WEST 174.26 FT. TO A 1/2" SOLID IRON PIN FOUND AND THE EASTERLY RIGHT OF WAY OF HAMLINE AVENUE;

THENCE ALONG SAID RIGHT OF WAY NORTH 00°16'12" EAST 37.30 FT. TO THE PLACE OF BEGINNING, CONTAINING 0.1492 ACRES OF LAND MORE OR LESS, AS SURVEYED IN DECEMBER OF 2017 BY GLEN A. GIBSON, REGISTERED PROFESSIONAL LAND SURVEYOR NO. 7107 AND BEING SUBJECT TO ALL LEGAL HIGHWAYS AND EASEMENTS OF RECORD, PARCEL # 84-39-02-06--000.




