COMMENCING AT AN IRON PIN SET AT THE NORTHEAST CORNER OF SAID LOT 18, THENCE, SOUTH 00 DEGREES - 00 MINUTES - 00 SECONDS WEST, 41.09 FEET TO AN IRON PIN SET ON THE WEST LINE OF FOX AVENUE, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 00 DEGREES - 00 MINUTES - 00 SECONDS WEST, 35.91 FEET TO A POINT; THENCE, LEAVING FOX AVENUE, SOUTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 118.00 FEET TO A POINT ON THE EAST LINE OF AN EXISTING ALLEY; THENCE, ALONG SAID ALLEY, NORTH 00 DEGREES - 00 MINUTES - 00 SECONDS EAST, 35.91 FEET TO AN IRON PIN SET; THENCE, NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS EAST, 118.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.0973 ACRES MORE OR LESS. 


