Situated in the City of Zanesville, County of Muskingum,  
and State of Ohio, to wit:

Being a part of the Third Quarter, First Township, Seventh  
Range of U.S. Military Land in the City of Zanesville,  
and more particularly bounded and described as follows:

Commencing, for reference, at a point on the east line  
of Goddard Avenue at the Northwest corner of Lot No. 1  
of Cox Addition to the City of Zanesville, as recorded  
in Re-Plat Book 1, Page 262 of the Records of Muskingum  
County; thence running North 03° 00' East on the East  
line of said Goddard Avenue extended 96.0 feet to a  
point which is the Northwest corner of land conveyed  
by John Kieswell, et us., to William G. Kieswell (Deed  
Book 93, Page 588); thence North 87° 00' West 20 feet  
to a point on the West line of said Goddard Avenue  
extended; thence North 03° 00' East along the West  
line of said Goddard Avenue 215.50 feet to a point;  
thence North 71° 00' West 93.0 feet to a point on the  
East line of Nutt Street (also known as Cattrell Lane);  
thence South 58° 11' West along said line of Nutt Street  
66.6 feet; thence continuing South 58° 11' West along  
the East line of Nutt Street 68.55 feet to an iron pin  
at Lynn Parks Southwest corner; thence across Nutt Street  
North 25° 27' West 40.00 feet; thence along the West line  
of Nutt Street south 58° 11' West 55.24 feet to an iron  
pin set the place of beginning; thence leaving Nutt Street  
North 32° 49' 00" West 132.00 feet to the East line of  
a 16.00 foot alley; thence along the East side of said  
alley North 58° 11' 00" East 150.00 feet to an iron pin  
set on the South line of a 40.00 foot wide Street  
(Goddard Street); thence along the South line of said  
street South 32° 49' 00" East 132.00 feet to an iron  
pin set at the intersection of the West line of Nutt  
Street; thence along the West line of Nutt Street South  
58° 11' 00" West 150.00 feet to the place of beginning,  
containing 0.455 acres more or less.




