

LEGAL DESCRIPTION

Commencing at an iron pipe at the Southeast corner of Lot 9 of Mitchells Addition as recorded in Plat Book 2 Page 56 of said County Records; Thence N 13° 21' 18" E for 96 Feet to a point; said point being the Northeast corner of Lot 10 of said addition and on the South Line of Parcel Recorded in Volume 59 Page 43 and 44; Thence N 13° 21' 18" E along the West Line of View Ave. for 378 feet (passing through an iron pipe at 182 feet) to an iron pin and the point of beginning;

Thence N 13° 21' 18" E for 109 feet to an iron pin on said West Line;

Thence N 84° 10' 22" W for 210 feet to an iron pin on the East line of an 16.5 Foot Alley; Thence S 13° 27' 05" W for 111 Feet to an iron pin on said East Line;

Thence S 84° 42' 21" E for 210.45 Feet to the point of beginning containing 0.525 Acres

Thence N 13° 21' 18" E for 117.60 feet to an iron pin;

Thence S 84° 10' 21" E for 150 Feet to an iron pin on the West Line of a 20 Foot Alley;

Thence S 13° 55' 20" W for 122.40 Feet along said alley to an iron pin;

Thence N 82° 23' 47" W for 148.24 Feet to the point of beginning containing 0.407 Acres




