DESCRIPTION OF SURVEY FOR DAVID FISHER JOB#820-3

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of the Third Quarter Township, Township #1, Range #7, of the US Military District, being all of the David Fisher property described in deed reference Deed Book Volume 1116, Page 294 of said county's deed records, known as Muskingum County Auditor's Parcel Number 84-52-01-26-000, and more particularly described as follows;

Commencing at an iron pin (found) at the Northwest corner of Lot #12 and Southwest corner of Lot #11 of M.V.D. Mitchell's Addition recorded Plat Book 2, Page 56, also being on the East line of Mitchell Street; thence N 15 12 40 E 63.12 feet along the East line of Mitchell Street to the Northwest corner of said Lot #11, also being on the South line of a 10 Acre Tract conveyed to A.V. Fell and George V. Fell by Evans recorded in deed reference Deed Book Volume 59, Page 43; thence N 15 12 40 E 343.58 feet into said 10 Acre Tract, extending (by deeds) the East line of Mitchell Street to an iron pipe (found) at the Northwest corner of the Jeffery Seward property as described in deed reference Deed Book Volume 1099, Page 23, passing an iron pipe (found) at 14.92 feet; thence N 21 02 50 E 77.47 feet continuing through said 10 Acre Tract and along the East line of Mitchell Street to an iron pin (found) at the place of beginning and Southwest corner of the property herein intended to be described;

- #1- thence N 15 05 40 E 118.42 feet continuing through said 10 Acre Tract and along the East line of Mitchell Street to an iron pin (found) at the Northwest corner of said Fisher property;
- #2- thence S 81 22 40 E 175.30 feet continuing through said 10 Acre Tract and along the North line of said Fisher property to an iron pin (set) at the Northeast corner of said Fisher property, being the East line of said 10 Acre Tract, and East line of a 20 foot wide alley (created by deeds) vacated by County Auditor Order #70-109 on January 27, 1971, also being the West line of the City of Zanesville property (no reference found), passing an iron pin (found) at 155.07 feet;
- #3- thence S 17 10 50 W 123.11 feet along the common line for said 10 Acre Tract, East line of said 20 foot alley, East line of said Fisher property, and West line of the City of Zanesville property to an iron pin (set) at the Southeast corner of said Fisher property;
- #4- thence N 80 00 30 W 170.37 feet through said 10 Acre Tract and along the South line of said Fisher property to the place of beginning, passing an iron pin (found) at 22.99 feet, containing 0.48 acres.

The bearings within the description are based on previous survey of the David Fisher property completed by Charles R. Harkness PLS #6885 on October 21, 1996. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R. Harkness Professional Land Surveyor #6885 from an actual survey completed on September 11, 1997, in accordance with Chapter 4733-37 of the Administrative Code, and is intended to be used for the legal transfer of the property described and does not intend to describe all or any easements of record, nor encroachments unless otherwise indicated.




