Part of Parcel No. 84-63-01-03-000 All of Parcel No. 84-63-01-02-000

Situated in the State of Ohio, County of Muskingum, Township of Washington
now the City of Zanesville:

Being a part of Lot 16 of Underwoods Reservation as Recorded in Deed Book E, Page 62 and part of Lot 9 of Muskingum Mining No. 2 as Recorded in Plat Book 2, Page 10 of the Plat Records in said Muskingum County and part of Quarter Township Three (3), Township One (1), Range Seven (7) of the United States Military Lands and part of property owned by David M. Wolfe and Recorded in Deed Book 1059, Page 224 and all of the property in deed Book 1059, Page 226 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an iron pin found at the southwest corner of Lot 8 of said Muskingum Mining Addition No. 2 as Recorded in Plat Book 2, Page 10; thence N 87° 29' 19" W (the base of bearings for this description is true north by an observation of the sun) 106.04 feet to an iron pin found at the southeast corner of said David M. Wolfe property; thence N 87° 33' 01" W along the south line of said Wolfe property 149.22 feet to an iron pin set at the true place of beginning for the following described parcel; thence N 3° 29' 57" E and through the lands of the Wolfe property 626.30 feet to an iron pin set; thence N 40° 40' 55" E 647.71 feet to an iron pin found at the northeast corner of the David M. Wolfe property and on the north line of Lot 9 of said Muskingum Mining Addition No. 2 and passing from said Lot 16 of Underwoods Reservation into said lot 9 at 403.47 feet; thence along the south line of Lot 2 and Lot 1 of Walnut Hills (P.B. 2, Pg. 2) and the south line of property owned by the City of Zanesville (Vol. 998, Pg. 487) and the north line of said Wolfe property the following 5 courses and distances:
1- N 87° 12' 05" W 149.95 feet to an iron pin found at the northwest corner of said Lot 9
2- N 87° 43' 26" W 219.15 feet to an iron pin set
3- N 24° 13' 37" W 249.48 feet to an iron pin set
4- N 45° 52' 36" W 163.68 feet to an iron pin set
5- N 58° 51' 06" W 76.89 feet to an iron pin set on the east line of the Baltimore an Ohio Railroad; thence S 27° 51' 23" W along said right of way 1228.83 feet to an iron pin set; thence along said right of way on a curve to the left having a radius of 5679.65 feet (the chord of which bears S 25° 41' 36" W 428.72 feet) an arc distance of 428.82 feet to a point, said point bears N 53° 48' 22" E 8.25 feet from a concrete monument found; thence S 87° 33' 01" E along the south line of said David M. Wolfe property and the north line of property owned by the City of Zanesville (Vol. 530, Pg. 894) a distance of 954.91 feet to the true place of beginning and passing through an iron pin found at 80.61 feet containing twenty three and one hundred eighty three thousands (23. 183) acres of which 0.332 of an acre is in Lot 9.

Part of Auditors Parcel No. 84-63-01-03-000 and all of auditors Parcel No. 84-63-01-02-000 (2.60 acres).

Subject to all legal right of ways and easements on record.

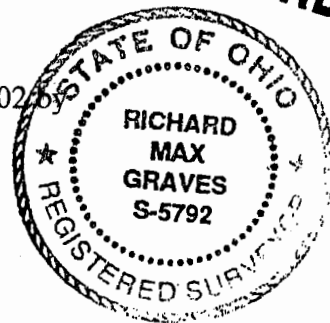
