

Situated in the State of Ohio, County of Muskingum, City of Zanesville, being part of the Third Quarter of Township 1, Range 7, United States Military Lands, and being a resurvey of Auditor's Parcel Number 85-36-01-07-000 conveyed to UNITED TECHNOLOGIES AUTOMOTIVE, INC. (referenced herein as UTA) by Deed Volume 1003, Page 251 of the Muskingum County Recorder's Office, and being more particularly bound and described as follows:

Beginning at a Concrete Monument Found in the easterly right-of-way line of Linden Avenue (66' wide) at the southwest corner of said UTA property, said point being the northwest corner of the property conveyed to AK Steel Corporation by D.V. 2195-555, said corner shown on a survey by Accurate Technologies dated October 19, 2007 in said AK Steel deed, thence along the easterly right-of-way line of Linden Avenue and the westerly line of said UTA property, **North 29 degrees 05 minutes 00 seconds East, 2797.60 feet** to a 3/4" Iron Pipe Found at the northern corner of the property shown on the map of property belonging to the A.E. Tiling Co., as recorded in Plat Book 2, Page 108, said point being at the intersection of the easterly right-of-way line of said Linden Avenue with the westerly line of the Ohio Central Railroad property (25' west of the center of the main tracks), and being the northern corner of said UTA property;

Thence along the easterly lines of said UTA property, and the westerly lines of said Ohio Central Railroad property, the following seven (7) courses:

- 1) **South 09 degrees 58 minutes 34 seconds West, 236.42 feet** to a 3/4" Iron Pipe Found;
- 2) **South 09 degrees 06 minutes 32 seconds West, 545.01 feet** to a 3/4" Iron Pipe Found;
- 3) **North 85 degrees 45 minutes 09 seconds West, 35.11 feet** to a 3/4" Iron Pipe Found;
- 4) **South 08 degrees 37 minutes 50 seconds West, 997.25 feet** to a 5/8" Iron Rebar Found w/Cap "Linn Engineering #7113";
- 5) **South 05 degrees 55 minutes 16 seconds West, 301.33 feet** to a Stone Found;
- 6) **South 06 degrees 25 minutes 26 seconds West, 278.54 feet** to a Stone Found;
- 7) **South 06 degrees 31 minutes 14 seconds West, 177.37 feet** to a 3/4" Iron Pipe Found at the southeast corner of said UTA property, said point being the northeast corner of the property conveyed to Armco, Inc. by D.V. 272-618;



Thence along the southerly line of said UTA property and the northerly line of said Armco, Inc. property, **South 66 degrees 03 minutes 04 seconds West, 205.61 feet** to a 3/4" Iron Pipe Found at an angle point in the southerly line of said UTA property, said point being a northeasterly corner of the property conveyed to National Gas and Oil Corporation (deed reference unknown - PPN-85-23-01-02-001);

Thence along the southerly line of said UTA property and the northerly line of said National Gas and Oil Property, **North 86 degrees 26 minutes 55 seconds West, 581.77 feet** to a 5/8" Iron Rebar Found at an angle point in the southerly line of said UTA property, said point being a northwest corner of said National Gas and Oil property, and in the northerly line of said AK Steel property;

Thence along the southerly line of said UTA property and the northerly line of said AK Steel property, **North 60 degrees 54 minutes 18 seconds West, 225.46 feet** to the True Point of Beginning, containing 28.531 Acres, more or less. Subject to any and all easements, right-of-ways, conditions and restrictions of record. BEARINGS SHOWN HEREON ARE BASED UPON THE RIGHT-OF-WAY LINE OF LINDEN AVENUE AS BEING NORTH 29 DEGREES 05 MINUTES 00 SECONDS EAST, AS SHOWN ON THE MAP OF PROPERTY BELONGING TO THE A.E. 



