DESCRIPTION FOR ROAD DEDICATION OF BETHESDA DR. THROUGH GENESIS HEALTHCARE SYSTEMS PROPERTY IN HARVARD PLACE SUBDIVISION

Thence along the existing east right-of-way of Bell Street and the west line of lot 27, N3°58'00"E a distance of 5.44 feet to a cross cut set being the TRUE POINT OF BEGINNING of new right-of-way herein described;

Thence continuing with west property line of lots 27and 26 and the east line of Bell Street, N3°58'00"E a distance of 60.00 to a cross cut set at the northerly edge of said new right-of-way;

Thence leaving the east right-of-way of Bell Street and passing through lot 26, S85°58'40"E a distance of 31.89 feet to point opposite the P.C. of a curve and being Sta.18+43.81, 35.00 feet Lt.;

Thence passing though lots 26, 25, a vacated alley and lot 11 on a curve turning to the left with an arc length of 188.94 feet, having a radius of 465.00 feet, having a delta angle of 23°16'51", having a chord bearing of N82°22'55"E, with a chord length of 187.64 feet to an iron pin set opposite a P.T. of a curve and being Sta. 20+46.97, 35.00 feet Lt.;

Thence continuing through lot 11, N70°44'29"E a distance of 68.35 feet to an iron pin set on the current right-of-way of Maple Avenue;

Thence leaving the northerly line of the new right-of-way and with the current right-ofway of Maple Avenue and the east line of lots 11, 10 and 9, \$19°05'54"E a distance of 60.00 feet to an iron pin set, point being \$\text{N19}^05'54"W\$ a distance of 30.67 feet from a \(\frac{1}{2}\)" iron pipe found, marking the southeast corner of lot 9 and the southeast corner of property conveyed to Genesis Healthcare System in Deed Volume 2639 Page 466;

Thence leaving the right-of-way of Maple Avenue and passing through lot 9 with the southerly line of the new right-of-way, \$70°44'29"W a distance of 68.19 feet to an iron pin set opposite a P.T. of a curve and being Sta. 20+46.97, 25.00 feet Rt.;

Thence continuing through lot 9, passing through a vacated alley and passing through lot 27 with a curve turning to the right with an arc length of 213.32 feet, having a radius of 525.00 feet, having a delta angle of 23°16'51", having a chord bearing of S82°22'55"W, with a chord length of 211.86 feet to a point opposite a P.C. of a curve and being Sta. 18+43.81 25.00 feet Rt.;

Thence continuing through lot 27, N85°58'40"W a distance of 31.83 feet to the TRUE POINT OF BEGINNING:

Containing 18075.49 square feet, 0.415 acres, more or less, subject to legal highways, assessments, restrictions, covenants and other easements of record.
