

Commencing at an iron pin at the northeast corner of Lot 199 in said Avalon Heights; thence along the south line of North Avenue south 89 degrees 50 minutes west 183 feet to the true place of beginning of the premises herein intended to be described; thence south 0 degrees 01 minutes 39 seconds east 285 feet to a point; thence south 89 degrees 50 minutes west 117.31 feet to a point; thence north 0 degrees 10 minutes west 285 feet to a point on the south line of North Avenue; thence along the south line of North Avenue north 89 degrees 50 minutes east 118 feet to the true place of beginning, containing seventy-seven hundredths (0.77) of an acre more or less.





Being a part of Avalon Heights Subdivision in the Tenth Ward as recorded in Plat Book 4, Page 58 bounded and described as follows:


Beginning at an iron pin at the northeast corner of Lot 199 in said Avalon Heights Subdivision; thence along the south line of North Avenue north 85 degrees 29 minutes west 183 feet to a point on the north line of Lot 203; thence severing Lot 203 crossing a vacated alley and severing Lot 194 south 4 degrees 37 minutes west 285 feet to a point in the centerline of Dayton Avenue; thence along the centerline of Dayton Avenue south 85 degrees 29 minutes east 183 feet to a point; thence along the west line of Rich Street north 4 degrees 37 minutes east 285 feet to the place of beginning, containing one and twenty hundredths (1.20) acres more or less, and being all of Lots 195, 196, 197, 198, 199, 200, 201, 202 and 28 front feet to Lots 194 and 203 and a part of a vacated alley (16 feet X 183 feet) by ordinance #79 - 96 and recorded in Deed Book 832, Page 338, and a part of Dayton Street (now vacated) by ordinance #81 - 179 and recorded in Deed Book , Page .


