Being a part of the Southeast Quarter of Section 16 and a part of the Northeast Quarter of Section 25 bounded and described as follows:

Beginning at a iron pin found next to a set sandstone at the northeast corner of Section 25; thence along the east line of Section 25 south 2 degrees 28 minutes 41 seconds west 1003.36 feet to a stone found; thence north 87 degrees 41 minutes 37 seconds west 2183.69 feet to an iron pin found; thence north 2 degrees 13 minutes 22 seconds east along an existing fence and said fence extended a distance of 2338.38 feet to an iron pin; thence along an existing wire fence line and some split rail fence line south 87 degrees 47 minutes 08 seconds east 2163.81 feet to an iron pin; thence south 1 degree 07 minutes 20 seconds west 290.0 feet to an iron pin found; thence south 1 degree 11 minutes 48 seconds west 1048.75 feet to the place of beginning, containing one hundred seventeen and thirteen hundredths (117.13) acres more or less.
