BEING A PART OF WATER STREET IN THE TOWN OF GAYSPORT (DEED VOLUME 17, PAGE 432-433 OF THE MUSKINGUM COUNTY DEED RECORDS), SITUATED IN SECTION 20, TOWNSHIP 12, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, BLUE ROCK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS

COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHWEST CORNER OF LOT 6 OF THE ABOVE SAID TOWN OF GAYSPORT;

THENCE WITH THE NORTH LINE OF SAID LOT 6 (SOUTH LINE OF LOT 5-EXTENDED), NORTH 73 DEGREES 00 MINUTES 00 SECONDS WEST 33.00 FEET TO AN IRON PIN SET IN THE CENTER OF WATER STREET, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE SAID CENTERLINE, SOUTH 17 DEGREES 00 MINUTES 00 SECONDS WEST 346.50 FEET (BY PLAT) TO A MAG NAIL SET;

THENCE LEAVING THE SAID CENTERLINE AND WITH THE NORTH LINE OF HENDERSON STREET (SOUTH LINE OF LOT 10-EXTENDED), NORTH 73 DEGREES 00 MINUTES 00 SECONDS WEST 33.00 FEET TO A POINT ON THE WEST LINE OF WATER STREET;

THENCE WITH THE SAID WEST LINE, NORTH 17 DEGREES 00 MINUTES 00 SECONDS EAST 346.50 FEET (PLAT) TO A POINT ON THE NORTH LINE OF LOT 6 (EXTENDED);

THENCE WITH THE SAID EXTENDED NORTH LINE, SOUTH 73 DEGREES 00 MINUTES 00 SECONDS EAST 33.00 FEET TO THE PLACE OF BEGINNING.




BEARINGS ARE BASED ON THE PREVIOUS PLAT OF THE TOWN OF GAYSPORT.

Situated in the State of Ohio County of Muskingum and Township of Blue Rock.

Being a part of lots 19 and 20 in the town of gaysville and part of the northeast quarter of section 20, township 12, range 12 bounded and described as follows:

Beginning at the northwest corner of said lot 19; thence south 67 degrees 07 minutes east a distance of 122.69 feet to the centerline of State route 60 and passing through an iron pin at 92.14 feet; thence south 33 degrees 02 minutes west along said centerline a distance of 147.17 feet to a point; thence north 60 degrees 07 minutes west a distance of 113.69 feet to an iron pin and passing through an iron pin at 30.04 feet. thence north 29 degrees 53 minutes east a distance of 132.00 feet to the true place of beginning containing Thirty Seven Hunderths of an acre more or less.


