COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 23; THENCE, NORTH 00 DEGREES - 24 MINUTES - 19 SECONDS WEST, 630.55 FEET TO AN IRON PIPE FOUND AT THE SOUTHEAST CORNER OF LANDS DESCRIBED IN DEED VOLUME 777, PAGE 61, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 00 DEGREES - 24 MINUTES - 19 SECONDS WEST, 726.34 FEET TO AN IRON PIPE; THENCE, NORTH 66 DEGREES - 47 MINUTES - 20 SECONDS EAST, 806.50 FEET TO A POINT IN THE CENTER OF COUNTY ROAD #66, PASSING AN IRON PIN FOUND AT 795.78 FEET; THENCE, SOUTH 13 DEGREES - 40 MINUTES - 06 SECONDS EAST, 179.72 FEET ALONG THE CENTERLINE OF SAID COUNTY ROAD TO A POINT; THENCE, SOUTH 54 DEGREES - 20 MINUTES - 04 SECONDS WEST, 460.24 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 15.00 FEET; THENCE, SOUTH 18 DEGREES - 22 MINUTES - 03 SECONDS EAST, 63.83 FEET TO AN IRON PIN SET; THENCE, SOUTH 38 DEGREES - 09 MINUTES - 20 SECONDS WEST, 687.52 FEET TO THE POINT OF BEGINNING, AND CONTAINING 7.269 ACRES MORE OR LESS.
