## LEGAL DESCRIPTION FOR RANDY TAYLOR

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF BRUSH CREEK, AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 24, TOWNSHIP 11, RANGE 13 AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1069, PAGE 616 OF THE MUSKINGUM COUNTY DEED RECORDS. BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 24, THENCE, NORTH 00 DEGREES - 00 MINUTES - 00 SECONDS EAST, 729.75 FEET TO A POINT; THENCE, NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 673.20 FEET TO A POINT; THENCE, NORTH 43 DEGREES - 00 MINUTES - 00 SECONDS WEST, 66.30 FEET TO A POINT; THENCE, NORTH 43 DEGREES - 00 MINUTES - 00 SECONDS WEST, 508.79 FEET TO A POINT; THENCE, SOUTH 18 DEGREES - 42 MINUTES - 00 SECONDS WEST, 228.00 FEET TO A POINT; THENCE, SOUTH 88 DEGREES - 28 MINUTES - 20 SECONDS WEST, 466.59 FEET TO A POINT; THENCE, SOUTH 21 DEGREES - 52 MINUTES - 00 SECONDS WEST, 490.02 FEET TO A POINT; THENCE, SOUTH 68 DEGREES - 36 MINUTES - 00 SECONDS WEST, 35.62 FEET TO A POINT; THENCE, SOUTH 83 DEGREES - 48 MINUTES - 00 SECONDS WEST, 216.35 FEET TO A POINT IN THE CENTER OF COUNTY ROAD #66 AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING ALONG THE CENTER OF SAID ROAD, THE FOLLOWING FIVE COURSES AND DISTANCES:

- 1) SOUTH 83 DEGREES - 48 MINUTES - 00 SECONDS WEST, 18.85 FEET TO A POINT.
- 2) SOUTH 71 DEGREES - 42 MINUTES - 00 SECONDS WEST, 107.48 FEET TO A POINT.
- 3) SOUTH 73 DEGREES - 51 MINUTES - 00 SECONDS WEST, 175.01 FEET TO A POINT.
- 4) ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 224.29 FEET, A LENGTH OF 188.02 FEET, THE CHORD OF WHICH BEARS NORTH 82 DEGREES - 31 MINUTES - 00 SECONDS WEST, 182.56 FEET TO A POINT.
- 5) THENCE, ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 318.67 FEET, A LENGTH OF 246.22 FEET, THE CHORD OF WHICH BEARS NORTH 27 DEGREES - 22 MINUTES - 50 SECONDS WEST, 240.14 FEET TO A POINT.

THENCE, LEAVING SAID ROAD, NORTH 81 DEGREES - 27 MINUTES - 01 SECONDS EAST, 226.18 FEET TO AN IRON PIN FOUND, PASSING AN IRON PIN FOUND AT 30.17 FEET; THENCE, NORTH 68 DEGREES - 51 MINUTES - 50 SECONDS EAST, 132.55 FEET TO AN IRON PIPE FOUND; THENCE, NORTH 46 DEGREES - 44 MINUTES - 26 SECONDS EAST, 75.00 FEET TO AN IRON PIPE FOUND; THENCE, SOUTH 62 DEGREES - 32 MINUTES - 12 SECONDS EAST, 162.00 FEET TO AN IRON PIN SET; THENCE, SOUTH 09 DEGREES - 20 MINUTES - 38 SECONDS EAST, 213.49 FEET TO THE POINT OF BEGINNING, PASSING AN IRON PIN SET AT 186.86 FEET AND CONTAINING 3.297 ACRES MORE OR LESS.



**SURVEY PLAT for RANDY TAYLOR**
